Section 5304(c) of Title 71 of the Pennsylvania Consolidated Statutes is amended to read: § 5304. Creditable nonstate service. 9 10 (c) Limitations on nonstate service. -- Creditable nonstate service credit shall be limited to: 11 12 intervening military service; (1)13 (2) other military service not exceeding five years; 14 service in any public school or public educational 15 institution in any state other than this Commonwealth or in 16 any territory or area under the jurisdiction of the United States; or service as an administrator, teacher, or 17

instructor in the field of education for any agency or

- 3 States, the total of such service not exceeding the lesser of
- 4 ten years or the number of years of active membership in the
- 5 system, as an officer or employee of the Department of

- 15 Federal Government, the total of such service not exceeding

- 19 Section 2. Section 5505 of Title 71 is amended by adding a
- 20 subsection to read:
- 21 § 5505. Contributions for the purchase of credit for
- 22 creditable nonstate service.

- 24 (f) Purchase of Federal civil service credit.--
- 25 Contributions on account of credit for service as a Federal
- 26 <u>civil service employee under section 5304(c)(5) (relating to</u>
- 27 creditable nonstate service) shall be equal to the present value
- 28 of the full actuarial cost of the increase in the projected
- 29 <u>superannuation annuity caused by the additional service</u>
- 30 credited. The amount contributed under this subsection shall not

- 1 be payable as a lump sum under section 5705(a)(4)(iii) (relating
- 2 to member's options).
- 3 Section 3. This act shall take effect immediately.
