AN ACT

1 Designating a bridge on that portion of State Route 403 over the
2 Two Lick Creek, Clymer Borough, Indiana County, as the
3 Sergeant James Robert Pantall Memorial Bridge.

4 The General Assembly of the Commonwealth of Pennsylvania
5 hereby enacts as follows:

6 Section 1. Sergeant James Robert Pantall Memorial Bridge.

7 (a) Findings.--

8 (1) Sergeant James Robert Pantall was raised in Clymer,
9 Pennsylvania, and attended Penns Manor High School until he
10 entered the United States Army.

11 (2) Sergeant Pantall served his country honorably during
12 the Vietnam War as a member of the 329th Transportation
13 Company, 5th Transportation Command (Terminal).

14 (3) On November 3, 1970, Sergeant Pantall was listed as

1 missing in action when he was a passenger on Landing Craft
2 Utility #63 that capsized five nautical miles south of Tan My
3 port, South Vietnam.

4 (4) Sergeant Pantall's remains were never recovered, and
5 his name is inscribed on the Courts of the Missing at the
6 Honolulu Memorial to honor his service and sacrifice.

7 (b) Designation.--The bridge located on State Route 403 in
8 Clymer Borough, Indiana County, over the Two Lick Creek is
9 hereby designated the Sergeant James Robert Pantall Memorial
10 Bridge.

11 (c) Signs.--The Department of Transportation shall erect and
12 maintain appropriate signs displaying the name of the bridge to
13 traffic in both directions on the bridge.

14 Section 2. Effective date.

15 This act shall take effect in 60 days.
