AN ACT

- 1 Providing for the Parent Involvement Leave Act.
- 2 The General Assembly of the Commonwealth of Pennsylvania
- 3 hereby enacts as follows:
- 4 Section 1. Short title.
- 5 This act shall be known and may be cited as the Parent
- 6 Involvement Leave Act.
- 7 Section 2. Definitions.
- 8 The following words and phrases when used in this act shall
- 9 have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 "Children of school age" or "child of school age." As
- 12 defined by section 1401(1) of the act of March 10, 1949 (P.L.30,
- 13 No.14), known as the Public School Code of 1949.
- "Employee." An individual from whose wages an employer is
- 15 required under the Internal Revenue Code of 1986 (Public Law 99-
- 16 514, 26 U.S.C. § 1 et seq.) to withhold Federal income tax.
- 17 "Employer." Includes the Commonwealth or any political

- 1 subdivision or board, department, commission or school district
- 2 thereof and any person employing 20 or more persons within this
- 3 Commonwealth, but except as hereinafter provided, does not
- 4 include religious, fraternal, charitable or sectarian
- 5 corporations or associations, except such corporations or
- 6 associations supported, in whole or in part, by governmental
- 7 appropriations. The term "employer" with respect to
- 8 discriminatory practices based on race, color, age, sex,
- 9 national origin or non-job-related handicap or disability,
- 10 includes religious, fraternal, charitable and sectarian
- 11 corporations and associations employing 20 or more persons
- 12 within this Commonwealth.
- 13 "Parent." The term includes a biological mother or father of
- 14 a child, a person who has legal custody of a child, a person who
- 15 acts as a guardian of a child or a person married or in a
- 16 domestic partnership with a person listed above.
- "School-related activity." An activity or meeting related to
- 18 a child's participation in an extracurricular activity or
- 19 educational meeting that may include, but shall not be limited
- 20 to:
- 21 (1) Parent-teacher conferences.
- 22 (2) Individualized Education Program meetings.
- 23 (3) Dropout prevention.
- 24 (4) Attendance, truancy or disciplinary issues.
- 25 (5) Concerts.
- 26 (6) Plays.
- 27 (7) Rehearsals.
- 28 (8) Sporting events.
- "Student with a disability." As defined by section 1301-A of
- 30 the act of March 10, 1949 (P.L.30, No.14), known as the Public

- 1 School Code of 1949.
- 2 Section 3. Parental involvement leave.
- 3 (a) General rule. -- Employers shall grant eight hours of
- 4 unpaid leave per year to any parent of a child of school age to
- 5 attend school-related activities.
- 6 (b) Requirements.--Leave granted under this section is
- 7 subject to the following:
- 8 (1) To be eligible, a parent must have been employed for
- 9 at least six out of the last 12 months with the employer.
- 10 (2) Leave shall be requested by the parent no fewer than
- 11 four days in advance of the school-related activity, or as
- soon as reasonably possible in case of an emergency.
- 13 (3) The parent must make a reasonable attempt to
- schedule the school-related activity during nonwork hours.
- 15 (4) The parent must provide written documentation if
- requested by the employer.
- 17 (c) Additional hours. -- A parent with a child that has an
- 18 Individualized Education Program under 22 Pa. Code § 14.131
- 19 (relating to IEP) or whose child is a student with a disability
- 20 shall be given four additional hours of unpaid leave to attend
- 21 meetings and activities related to the education of the child.
- 22 Section 4. Employer.
- 23 (a) General rule. -- An employer shall approve or deny leave
- 24 within 48 hours of the request.
- 25 (b) Denial of leave. -- If an employer denies leave, the
- 26 employer shall provide written justification for the denial to
- 27 the employee.
- 28 Section 5. Retaliation.
- 29 An employer shall not terminate, demote, suspend or otherwise
- 30 discriminate against an employee who takes leave under this act.

- 1 Section 6. Rules and regulations.
- 2 The Secretary of Labor and Industry shall promulgate rules
- 3 and regulations to administer and enforce this act.
- 4 Section 7. Effective date.
- 5 This act shall take effect in 90 days.
