AN ACT

- 1 Amending Title 62 (Procurement) of the Pennsylvania Consolidated
- Statutes, in small and disadvantaged businesses, further
- providing for definitions; and providing for small business
- 4 reserve.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. The introductory paragraph and the definition of
- 8 "disadvantaged business" in section 2102 of Title 62 of the
- 9 Pennsylvania Consolidated Statutes are amended and the section
- 10 is amended by adding definitions to read:
- 11 § 2102. Definitions.
- 12 [Subject] Notwithstanding section 103 (relating to
- 13 definitions) and subject to section 2103 (relating to
- 14 regulations), the following words and phrases when used in this
- 15 chapter shall have the meanings given to them in this section
- 16 unless the context clearly indicates otherwise:
- 17 "Disadvantaged business." A small business which is owned or
- 18 controlled by a majority of persons, not limited to members of

- 1 minority groups, who:
- 2 (1) have been deprived of the opportunity to develop and
- 3 maintain a competitive position in the economy because of
- 4 social disadvantages[.]; or
- 5 (2) are veterans, including service-disabled veterans.
- 6 <u>"Service-disabled veteran." A veteran who possesses either</u>
- 7 <u>an adjudication letter from the United States Veterans'</u>
- 8 Administration establishing a service-connected disability
- 9 rating or a disability determination from the United States
- 10 Department of Defense.
- 11 * * *
- 12 <u>"Veteran." An individual who:</u>
- (1) Served in the active United States military in any
- of the four current branches and all previous branches,
- including a reserve component or the National Guard.
- 16 (2) Was released or discharged from active military
- 17 service under conditions other than dishonorable.
- 18 (3) Possesses a certificate of release or discharge from
- 19 active duty.
- 20 Section 2. Title 62 is amended by adding a section to read:
- 21 § 2109. Small business reserve program.
- 22 (a) Small business reserve. -- The department shall establish
- 23 a small business reserve program for the purpose of increasing
- 24 economic opportunities for small and disadvantaged businesses
- 25 and affording small and disadvantaged businesses the opportunity
- 26 to bid on State government contracts without competing with
- 27 <u>larger businesses</u>. All procurement by the department shall be
- 28 eligible for designation for the small business reserve program,
- 29 and shall be published in the same manner as required for a
- 30 request for proposal or an invitation for bid.

- 1 (b) Reserve account. -- Notwithstanding any other provision of
- 2 this title to the contrary, the department shall structure its
- 3 procurement procedures to reserve up to 10% of the total dollar
- 4 <u>value of its procurement contracts, including public works,</u>
- 5 construction and professional services and designed professional
- 6 <u>services contracts</u>, to be made directly to qualified small and
- 7 <u>disadvantaged businesses</u>. However, the total dollar value of
- 8 procurements by the department shall not include the value of
- 9 any contract to which this subsection would not apply because of
- 10 a conflict with Federal law.
- 11 (c) Awards. -- The department shall award a procurement
- 12 <u>contract designated for a small business reserve to the small</u>
- 13 <u>and disadvantaged business that submits a bid or proposal that:</u>
- 14 <u>(1) is the lowest bid price;</u>
- 15 (2) is the lowest evaluated bid price, if the invitation
- for bid or request for proposal so provides; or
- 17 (3) is in the best interest of the Commonwealth.
- 18 (d) Other Commonwealth agencies.--
- 19 (1) A Commonwealth agency may collaborate with the
- 20 department to structure its procurement procedures to provide
- 21 <u>for a small business reserve program which shall be subject</u>
- 22 <u>to the requirements of this section.</u>
- 23 (2) Upon request, the department shall assist the
- 24 procurement unit of a Commonwealth agency with the
- 25 <u>development and implementation of a small business reserve.</u>
- 26 (e) Construction and application. --
- 27 (1) The provisions of this section shall not be
- construed to preclude any small and disadvantaged business
- from competing for any other contract that is not
- 30 specifically designated for the small business reserve

- 1 program.
- 2 (2) The provisions of this section shall apply to any
- 3 eligible small business as defined under 62 Pa.C.S. § 2102
- 4 <u>(relating to definitions).</u>
- 5 (f) Regulations. -- The department shall adopt and promulgate
- 6 regulations to govern the provisions of this section. The
- 7 <u>regulations shall:</u>
- 8 (1) Establish a comprehensive bidder's list of eliqible
- 9 small and disadvantaged businesses.
- 10 (2) Provide procedures for maintaining the list in
- 11 paragraph (1).
- 12 (3) Include any other information the department
- determines necessary and appropriate to carry out the
- 14 <u>provisions of this section.</u>
- 15 (g) Reports. -- On or before December 31, 2014, and on or
- 16 before each December 31 thereafter, the department shall submit
- 17 a report to the Chief Clerk of the Senate and the Chief Clerk of
- 18 the House of Representatives on the operation and effectiveness
- 19 of the Small Business Reserve Program. The report shall include
- 20 the following:
- 21 (1) The total number and dollar value of payments the
- department made to small and disadvantaged businesses
- 23 pursuant to designated small business reserve contracts.
- 24 (2) The total number and dollar value of payments the
- department made to small and disadvantaged businesses that
- 26 were not designated as small business reserve contracts.
- 27 (3) The total dollar value of payments made by the
- department under procurement contracts.
- 29 <u>(4) Information on any Commonwealth agency that has</u>
- implemented a small business reserve program, including

- information required under paragraphs (1), (2) and (3).
- 2 (5) Any other information or recommendation the
- 3 <u>department determines necessary.</u>
- 4 Section 3. This act shall take effect immediately.
