AN ACT

Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain 2 provisions applicable as well to private and parochial 3 schools; amending, revising, consolidating and changing the laws relating thereto," in miscellaneous provisions relating to institutions of higher education, prohibiting scholarship 6 displacement at public institutions of higher education under certain circumstances. 8 9 The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. The act of March 10, 1949 (P.L.30, No.14), known 12 as the Public School Code of 1949, is amended by adding a 13 section to read: 14 Section 2002-I. Prohibition on scholarship displacement at 15 public institutions of higher education. 16 (a) General rule. -- A public institution of higher education 17 may reduce a student's institutional financial aid as a result of the awarding of private scholarships to the student only 18 19 under the circumstances enumerated in subsections (b) and (c). 20 (b) When institutional financial aid exceeds financial

- 1 need.--If a student's total financial aid from all sources
- 2 <u>exceeds the student's financial need, a public institution of</u>
- 3 <u>higher education may reduce the student's institutional</u>
- 4 <u>financial aid until the student's total financial aid no longer</u>
- 5 exceeds the student's financial need.
- 6 (c) When approval of organization given. -- In addition to the
- 7 reduction authorized under subsection (b), a public institution
- 8 <u>of higher education may reduce a student's institutional</u>
- 9 <u>financial aid if the public institution of higher education</u>
- 10 receives approval from the organization that awarded the private
- 11 scholarship that caused the reduction authorized under
- 12 <u>subsection (b).</u>
- 13 <u>(d) Student athletes.--If a student is an athlete at a</u>
- 14 <u>public institution of higher education</u>, the <u>public institution</u>
- 15 of higher education may reduce the student's institutional
- 16 <u>financial aid in order to comply with the individual or team</u>
- 17 financial aid restrictions of an athletic association,
- 18 conference or other group or organization with authority over
- 19 intercollegiate athletics including, but not limited to, the
- 20 National Collegiate Athletic Association.
- 21 (e) As used in this section, the following words and phrases
- 22 shall have the meanings given to them in this subsection unless
- 23 the context clearly indicates otherwise:
- 24 "Expected family contribution." The expected family
- 25 contribution as determined under section 474 of the Higher
- 26 Education Act of 1965 (Public Law 89-329, 20 U.S.C. § 1087nn).
- 27 "Financial need." The cost of attendance minus expected
- 28 family contribution.
- 29 "Institutional financial aid." The sum of all need-based and
- 30 merit-based grants, scholarships, tuition waivers and all other

- 1 forms of financial assistance provided to a student by a public
- 2 institution of higher education that are not loans or work-study
- 3 programs.
- 4 "Private scholarship." A scholarship awarded by a business,
- 5 private foundation, nonprofit organization or service group.
- 6 The term does not include an award funded by a private
- 7 organization which is affiliated with a public institution of
- 8 <u>higher education and requests the public institution of higher</u>
- 9 <u>education's assistance in selecting the recipient of the award.</u>
- 10 "Public institution of higher education." Any of the
- 11 <u>following:</u>
- 12 (1) A community college operating under Article XIX-A
- 13 (2) A rural regional college established under Article
- 14 $\underline{XIX-G.}$
- 15 (3) A university within the State System of Higher
- 16 Education under Article XX-A.
- 17 (4) A State-related institution as defined in section
- 18 <u>2001-C</u>.
- 19 (5) The Thaddeus Stevens College of Technology.
- 20 (6) The Pennsylvania College of Technology.
- 21 "Student." An individual enrolled at a public
- 22 <u>institution of higher education.</u>
- 23 Section 2. This act shall take effect on July 1, 2022 or
- 24 immediately, whichever occurs first.
