AN ACT

- 1 Providing for the establishment of a Statewide program to match
- 2 community volunteers with mental health care recipients and
- for powers and duties of the Secretary of Public Welfare; and
- 4 making an appropriation.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Short title.
- 8 This act shall be known and may be cited as the Statewide
- 9 Compeer Act.
- 10 Section 2. Establishment of Compeer program.
- 11 The Secretary of Public Welfare shall:
- 12 (1) Establish a mental health program, to be known as
- 13 Compeer, to match a community volunteer with a person who has
- a mental illness for the purpose of providing a meaningful
- 15 friendship.
- 16 (2) In conjunction with each county or adjoining
- 17 counties, establish a Compeer program through the Office of

- 1 Mental Health within the Department of Public Welfare. Each
- 2 program shall provide a report to the Secretary of Public
- 3 Welfare on a yearly basis.
- 4 (3) Appoint a coordinator of the Compeer program within
- 5 the Department of Public Welfare.
- 6 (4) Promulgate rules and regulations to establish the
- 7 Compeer program in each county or adjoining counties.
- 8 (5) Disburse \$1,500 per year to each county
- 9 participating in the Compeer program for use in administering
- 10 the program.
- 11 Section 3. Powers and duties of Statewide Compeer Director.
- 12 The Secretary of Public Welfare shall appoint a person to a
- 13 position known as Statewide Compeer Director. The powers and
- 14 duties of the Statewide Compeer Director are as follows:
- 15 (1) To create a mandated program for each county or
- 16 adjoining counties in this Commonwealth.
- 17 (2) To designate a county coordinator for each county
- 18 Compeer program.
- 19 (3) To organize yearly Statewide meetings of
- 20 representatives from all the county Compeer programs for the
- 21 purpose of sharing information.
- 22 (4) To work with national Compeer organizations in
- developing the Compeer program.
- 24 (5) To work at the State level with fundraising and
- advertising for the Compeer program.
- 26 Section 4. Appropriation.
- The sum of \$100,000, or as much thereof as may be necessary,
- 28 is hereby appropriated to the Department of Public Welfare for
- 29 the fiscal year July 1, 1995 to June 30, 1996, to carry out the
- 30 provisions of this act.

- 1 Section 5. Effective date.
- 2 This act shall take effect in 60 days.
