AN ACT

- 1 Providing for a Postsecondary Education Tuition Reimbursement
- 2 Program for volunteer firefighters and emergency services
- 3 personnel.
- 4 The General Assembly finds that, since volunteer firefighters
- 5 and emergency services personnel provide essential public
- 6 services and save taxpayers billions of dollars annually in
- 7 communities across this Commonwealth, this act shall provide
- 8 significant assistance to them in attaining a quality
- 9 postsecondary education.
- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby enacts as follows:
- 12 Section 1. Short title.

- 1 This act shall be known and may be cited as the Volunteer
- 2 Firefighter and Emergency Services Postsecondary Education
- 3 Tuition Reimbursement Program Act.
- 4 Section 2. Definitions.
- 5 The following words and phrases when used in this act shall
- 6 have the meanings given to them in this section unless the
- 7 context clearly indicates otherwise:
- 8 "Agency." The Pennsylvania Higher Education Assistance
- 9 Agency.
- 10 "Community colleges." Institutions now and hereafter created
- 11 pursuant to Article XIX-A of the act of March 10, 1949 (P.L.30,
- 12 No.14), known as the Public School Code of 1949, or the former
- 13 act of August 24, 1963 (P.L.1132, No.484), known as the
- 14 Community College Act of 1963.
- 15 "State-owned university." A university which is part of the
- 16 State System of Higher Education as established under Article
- 17 XX-A of the act of March 10, 1949 (P.L.30, No.14), known as the
- 18 Public School Code of 1949, and all branches and campuses of a
- 19 State-owned university.
- 20 "State-related universities." The Pennsylvania State
- 21 University, the University of Pittsburgh, Temple University and
- 22 Lincoln University and their branch campuses.
- 23 Section 3. Tuition assistance program.
- 24 (a) Establishment.--There is hereby established the
- 25 Volunteer Firefighter and Emergency Services Postsecondary
- 26 Education Tuition Reimbursement Program.
- 27 (b) Credits or payments. -- The tuition reimbursement program
- 28 shall consist of a credit or payment by a community college,
- 29 State-owned university or State-related university of 50% of a
- 30 qualified student's share of tuition for each course credit,

- 1 with payment from the Commonwealth going directly to the
- 2 community college, State-owned university or State-related
- 3 university for such credits or payments.
- 4 (c) Qualifications. -- Any applicant who meets the following
- 5 criteria shall be eliqible for tuition assistance under this
- 6 act:
- 7 (1) The applicant must be a resident of this
- 8 Commonwealth.
- 9 (2) The applicant has successfully completed the
- 10 requirements for and has received certification as a
- 11 Firefighter I, II or III, Fire Officer I or II or Fire
- 12 Instructor I or II from the Pennsylvania Fire Academy or one
- of its delegated authorities consistent with the National
- Board of Professional Qualifications or the applicant is
- 15 certified as an Emergency Medical Technician by the
- Department of Health as provided for in the act of July 3,
- 17 1985 (P.L.164, No.45), known as the Emergency Medical
- 18 Services Act.
- 19 (3) The applicant must provide the community college,
- 20 State-owned university or State-related university with a
- 21 sworn statement of fact by the fire chief, president or
- 22 commissioner of a volunteer fire department, nonprofit
- 23 ambulance service, nonprofit rescue squad or nonprofit
- hazardous material response team, of which the applicant is a
- volunteer, attesting that the applicant has participated in
- at least 30% of the volunteer organization's emergency
- 27 responses within the last 18 months. A junior volunteer 16
- 28 through 18 years of age must have participated in at least
- 29 20% of the emergency responses and have attended at least 20
- 30 hours of training or classroom instruction on an annual

- 1 basis, as certified by the fire chief, president or
- 2 commissioner of the volunteer organization.
- 3 (4) The applicant must make an application to the agency
- 4 for any other financial assistance.
- 5 (d) Limitation. -- No applicant shall be eligible for tuition
- 6 reimbursement under this act for more than five academic years.
- 7 Section 4. Reimbursement of tuition costs.
- 8 The agency shall reimburse the community college, State-owned
- 9 university or State-related university an amount equal to 50% of
- 10 the cost of a course credit for each course where tuition
- 11 reimbursement is granted pursuant to this act. The
- 12 reimbursements shall be verified by enrollment and itemized by
- 13 the applicant for auditing purposes under this act. The
- 14 reimbursements shall be made annually by the agency to the
- 15 appropriate community college, State-related university or
- 16 State-owned university.
- 17 Section 5. Funding.
- 18 The General Assembly shall annually include in the
- 19 appropriation to the Pennsylvania Higher Education Assistance
- 20 Agency in the General Appropriation Act an appropriation from
- 21 the General Fund in an amount sufficient to make tuition
- 22 reimbursement payments pursuant to this act.
- 23 Section 6. Regulations.
- 24 The agency shall in a manner provided by law promulgate rules
- 25 and regulations necessary to carry out this act.
- 26 Section 7. Effective date.
- 27 This act shall take effect July 1, 2000, or immediately,
- 28 whichever is later.
