AN ACT

- 1 Amending the act of August 21, 1953 (P.L.1273, No.361), entitled
- 2 "An act to regulate the business of private detectives,
- investigators and watch, guard, or patrol agencies, and the
- 4 licensing thereof in each county; providing penalties,"
- 5 further excluding certain persons from the provisions of the
- 6 act.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 15, act of August 21, 1953 (P.L.1273,
- 10 No.361), known as "The Private Detective Act of 1953," is
- 11 amended to read:
- 12 Section 15. Application of Act.--Nothing in this act shall
- 13 apply to any detective officer or man belonging to the
- 14 Pennsylvania State Police, or to the police force of any county,
- 15 city, borough, township, or incorporated town, or any employe of
- 16 such State Police, or such police force, appointed or elected by
- 17 due authority of law, while engaged in the performance of their

- 1 official duties or while in engaged off-duty in the performance
- 2 of duties as set forth in clause 11 of subsection (b) of section
- 3 2, nor to any person, partnership, association, or corporation,
- 4 or any bureau or agency, whose business is exclusively the
- 5 furnishing of information as to the business and financial
- 6 standing and credit responsibility of persons, partnerships,
- 7 associations, or corporations, or as to the personal habits and
- 8 financial responsibility of applicants for insurance, indemnity
- 9 bonds, or commercial credit, or of claimants under insurance
- 10 policies, and whose business does not embrace other activities
- 11 described in section 2 of this act, nor to any corporation duly
- 12 authorized by the Commonwealth to operate a fire alarm
- 13 protection business, nor to any person while engaged in the
- 14 business of adjuster for an insurance company, nor to any person
- 15 regularly employed as special agent, detective or investigator
- 16 exclusively by one employer in connection with the affairs of
- 17 that employer only, nor to any charitable or philanthropic
- 18 society or association duly incorporated under the laws of the
- 19 Commonwealth and which is organized and maintained for the
- 20 public good and not for private profit, nor shall anything in
- 21 this act contained be construed to affect in any way attorneys
- 22 or counselors at law in the regular practice of their
- 23 profession, but such exemption shall not enure to the benefit of
- 24 any employe or representative of such attorney or counselor at
- 25 law who is not employed solely, exclusively and regularly by
- 26 such attorney or counselor at law, nor to persons in the
- 27 exclusive employment of common carriers subject to regulation by
- 28 the interstate commerce commission or the Public Utility
- 29 Commission of the Commonwealth of Pennsylvania, nor to
- 30 investigators in the employment of credit bureaus. [No] Except

- 1 for the duties set forth in clause (11) of subsection (b) of
- 2 section 2 which may be performed by any detective officer or a
- 3 member of the Pennsylvania State Police or to the police force
- 4 of any county, city, borough, township or incorporated town, or
- 5 any employe of such State Police or such police force appointed
- 6 or elected by due authority of law, no person, partnership,
- 7 association, corporation, or any bureau or agency, exempted
- 8 hereunder from the application of this act, shall perform any
- 9 manner of detective service as described in section 2 hereof for
- 10 any other person, partnership, association, corporation, bureau
- 11 or agency, whether for fee, hire, reward, other compensation,
- 12 remuneration, or consideration, or as an accommodation without
- 13 fee, reward, or remuneration, or by a reciprocal arrangement
- 14 whereby such services are exchanged on request of parties
- 15 thereto. The commission of a single act prohibited by this act
- 16 shall constitute a violation thereof.
- 17 Nothing in this act shall be construed to affect or prohibit
- 18 the right of any person to form, or become affiliated with, or
- 19 to continue as a member of, any union, association, society, or
- 20 organization of his own choosing.
- 21 Section 2. This act shall take effect immediately.
