A RESOLUTION

- 1 Urging the Commonwealth to upgrade its broadband communications
 - network for use by the private and public sectors in the
- 3 Northern Tier of this Commonwealth.
- 4 WHEREAS, Many of the communities in the region of this
- 5 Commonwealth referred to as the Northern Tier lack competitive
- 6 access to broadband communications and wireless phone services
- 7 in the region, which impedes the speed of response in matters of
- 8 public safety, economic development and research, analysis and
- 9 education; and

- 10 WHEREAS, The Marcellus Shale natural gas industry is actively
- 11 developing extensive operations in the Northern Tier and lacks
- 12 access to adequate broadband communications and wireless phone
- 13 services in the region, impacting the speed and effectiveness of
- 14 industry development; and
- 15 WHEREAS, The wireless communications industry did not have
- 16 great financial incentive in the past to develop infrastructure
- 17 to improve coverage in the Northern Tier because of limited
- 18 population; however, utilizing Commonwealth-owned infrastructure

- 1 and wireless communications, industry can eliminate much of its
- 2 upfront infrastructure development costs and more effectively
- 3 cover the region with its services to meet the expanding
- 4 communications needs; and
- 5 WHEREAS, The Commonwealth owns and maintains a vast number of
- 6 communications towers and related infrastructure across the
- 7 Northern Tier that must be upgraded to adequately support
- 8 multiple Commonwealth needs for enhanced broadband
- 9 communications in the region; and
- 10 WHEREAS, Financial, engineering and construction support from
- 11 wireless communications and natural gas industries could be
- 12 provided to ensure that the Commonwealth's communications tower
- 13 sites, related facilities and resulting broadband communications
- 14 network meet or exceed their industries' highest quality control
- 15 and performance standards to maximize their effective, long-term
- 16 use; and
- 17 WHEREAS, The resulting broadband communications network would
- 18 significantly benefit all pertinent Commonwealth agencies,
- 19 authorities, boards, commissions, councils, departments, offices
- 20 and communities in the region and the development of regional
- 21 business and industry, including, but not limited to, the
- 22 Marcellus Shale natural gas industry and wireless communications
- 23 industry; and
- 24 WHEREAS, The community, business and industry safety,
- 25 economic development, research analysis and educational
- 26 opportunities are of paramount importance; and
- 27 WHEREAS, The Commonwealth should encourage, invite and guide
- 28 wireless communications and natural gas industry collaboration
- 29 to facilitate the most mutually advantageous outcome to all
- 30 parties in the Northern Tier; therefore be it

- 1 RESOLVED, That the Senate urge the Commonwealth to upgrade
- 2 its broadband communications network for use by the private and
- 3 public sectors in the Northern Tier of this Commonwealth.
