| 3 | WHEREAS, Due to the events of September 11, 2001, it is clear |
| 4 | that terrorist attacks may occur in any town or neighborhood of |
| 5 | this Commonwealth; and |
| 6 | WHEREAS, The Congress of the United States has allocated \$85 |
| 7 | million to Pennsylvania over the last four years to train and |
| 8 | equip our first responders; and |
| 9 | WHEREAS, The General Assembly has appropriated large sums to |
| 10 | fund homeland security initiatives; and |
| 11 | WHEREAS, The Pennsylvania Emergency Management Agency (PEMA) |
| 12 | has provided guidance to communities in the development and |
| 13 | coordination of an interoperability communication system, which |
| 14 | includes an 800 megahertz radio system and the voice and data |
| 15 | satellite communication systems PaSTAR (the Pennsylvania |
| 16 | Statewide Telecommunications and Alerting System) and SEVAN (the |
| 17 | Satellite Emergency Voice Alerting Network); and |

1 WHEREAS, In order to create a regional network of seamless 2 communication, many townships and boroughs have updated their 3 local emergency response plans to respond to terrorist acts and 4 have established mutual aid agreements with neighboring 5 municipalities; and

6 WHEREAS, First responders such as local police and fire 7 departments can utilize these frequencies in coordination with 8 Federal and State law enforcement agencies in the event of a 9 terrorist attack; therefore be it

10 RESOLVED, That the Senate of Pennsylvania acknowledge that 11 Congress has provided funding for emergency preparedness 12 initiatives; and be it further

13 RESOLVED, That the Senate of Pennsylvania urge Congress to 14 continue to provide the necessary funding for further 15 initiatives, including increased interoperability between 16 Federal, State and local law enforcement agencies and first 17 responders; and be it further

18 RESOLVED, That copies of this resolution be transmitted to 19 the presiding officers of each house of Congress and to each 20 member of Congress from Pennsylvania.
