- 19 MISDEMEANORS OF THE THIRD DEGREE within the jurisdiction of the

- 24 (b) Public service programs. -- A district justice may, in
- 25 <u>lieu of making a disposition, authorize an offender to</u>

- 6 (c) Completion of program. -- The district justice shall
- 7 dismiss the charges and shall relieve the person of the

- 10 (d) Refusal to accept or complete program. -- If the person
- 11 refuses to accept the conditions required by the district
- 12 justice or fails to complete the program without good cause or
- 13 violates any condition of the program without good cause, the
- 14 district justice shall proceed on the charges as provided by
- 15 <u>law.</u>
- 16 (e) Immunity.--A district justice and any public service or
- 17 charitable organization supervising or administering a public
- 18 service program under this section shall be immune from any
- 19 civil action for damages brought by a person admitted to this
- 20 program. Nothing in this section shall be construed to limit or
- 21 <u>otherwise affect or preclude liability resulting from gross</u>
- 22 <u>negligence or intentional misconduct</u>. Reckless, willful or
- 23 wanton misconduct constitutes gross negligence.
- 24 (f) Definition. -- As used in this section the term "district
- 25 <u>justice" includes a judge of the Pittsburgh Magistrates Court.</u>
