AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
 Statutes, further providing for special registration plates
 generally and for personal registration plates; and making
 editorial changes.

 The General Assembly of the Commonwealth of Pennsylvania
 hereby enacts as follows:
- 7 Section 1. Sections 1333(b.1), 1341, AND 1786(h)(2) and 1931 <--
- 8 of Title 75 of the Pennsylvania Consolidated Statutes are
- 9 amended to read:
- 10 § 1333. Lost, stolen, damaged or illegible registration plate.
- 11 * * *
- 12 (b.1) Illegible registration plate. -- The department may
- 13 reissue a registration plate upon request by a registrant when
- 14 it is determined by an authorized representative of the
- 15 department or law enforcement that the registration plate is
- 16 illegible from a reasonable distance. The department may select
- 17 the style of the reissued registration plate and, except in the
- 18 case of personal registration plates issued under section 1341

- 1 (relating to special registration plates [generally]), the
- 2 registration plate number.
- 3 * * *
- 4 § 1341. Special registration plates [generally].
- 5 (a) General rule. -- Upon request by the applicant, the
- 6 department may issue registration plates consisting of any
- 7 combination of numbers, letters or numbers and letters. [These
- 8 special plates may be issued for special groups or for special
- 9 purposes and bear an appropriate designation. Special groups may
- 10 charge a fee for authorization to request a registration plate
- 11 bearing the name of the group.] They shall have the same force
- 12 and effect as regular registration plates. The department may
- 13 refuse any combination of letters and numbers for cause and
- 14 shall adopt reasonable rules and regulations for the issuance of
- 15 the plates and for carrying out the provisions of this section.
- 16 The applicant shall comply with all laws and regulations
- 17 pertaining to registration including the payment of any
- 18 additional fees.
- (b) Personal registration plates. -- Upon request by the
- 20 applicant, the department is authorized to issue personal
- 21 registration plates. The department is authorized to reissue a
- 22 combination of numbers or letters for a personal plate if the
- 23 department records reveal that no activity, such as renewal or
- 24 transfer of the personal registration plate, has occurred for a
- 25 period of five or more consecutive years and provided that the
- 26 personal registration plate was never reported as lost or
- 27 stolen. Whenever the department reissues an inactive personal
- 28 plate, the department may purge its records of all references to
- 29 the previous owners of that personal plate. The department
- 30 shall, however, note upon its records the reissuance of the

- 1 personal plate and to whom the plate was issued. [The special] \underline{A}
- 2 <u>personal</u> registration plate may be used only on a passenger car
- 3 {or}, motorcycle, truck, with a registered gross weight of not <-
- 4 more than [10,000] 14,000 pounds, MOTORCYCLE, trailer or motor <--
- 5 home.
- 6 (c) Organization registration plates. -- Upon request by the
- 7 applicant, the department is authorized to issue organization
- 8 registration plates. Organization registration plates may be
- 9 <u>issued for special groups or for special purposes and bear an</u>
- 10 appropriate designation. Special groups may charge a fee for
- 11 <u>authorization to request a registration plate bearing the name</u>
- 12 of the group. If the vehicle is licensed to a business that is
- 13 not a member of the special group, the department shall issue
- 14 the plate as long as the business owner or officer making
- 15 application is a member of that group. An organization
- 16 registration plate may be used only on a passenger car or truck, <--
- 17 with a registered gross weight of not more than 14,000 pounds or <--

- 21 (h) Reinstatement of voluntarily surrendered registration
- 22 plate and card.--

- 24 (2) Any registration plate issued under sections 1340
- 25 (relating to antique and classic plates) and 1341 (relating
- to [personal plate] special registration plates) shall be
- 27 returned by the department to the owner of the motor vehicle
- upon receipt of proof of financial responsibility.

- 30 SECTION 1.1. SECTION 1931 OF TITLE 75, AMENDED NOVEMBER 25, <--

- 1 2013 (P.L.974, NO.89), IS AMENDED TO READ:
- 2 § 1931. [Personal] <u>Special</u> registration plates.
- 3 The fee for issuance of a [personal] special registration
- 4 plate shall be \$76 which shall be in addition to the annual <--
- 5 registration fee. Only one payment of the issuance fee shall be
- 6 charged for each [personal] special registration issued or
- 7 replaced.
- 8 Section 2. This act shall take effect in 120 days.
