AN ACT

- 1 Authorizing the establishment of conservation commissions by certain political subdivisions.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The governing body of any city, borough,
- 6 township, or incorporated town, or group of two or more such
- 7 political subdivisions, may by ordinance REDESIGNATE AN EXISTING <---
- 8 MUNICIPAL PARK AND/OR RECREATION BOARD AS A PARK, RECREATION AND
- 9 CONSERVATION COMMISSION TO EXERCISE, IN ADDITION TO POWERS
- 10 ALREADY GRANTED, THE POWERS AND AUTHORITY GRANTED IN THIS ACT,
- 11 OR MAY establish a AN INDEPENDENT conservation commission for
- 12 the promotion, conservation, protection and development of
- 13 natural resources, including watershed resources, located within
- 14 its or their territorial limits. The county conservation
- 15 districts shall coordinate the activities of the conservation

- 1 commission COMMISSIONS in matters of INVOLVING TWO OR MORE
- 2 CONSERVATION COMMISSIONS WITHIN THE county. concern.
- 3 Section 2. A conservation commission shall be composed of no

- 4 less than three nor more than seven residents of the political
- 5 subdivision establishing the commission, who shall be appointed
- 6 and all vacancies filled by the governing body of the political
- 7 subdivision. Where two or more political subdivisions jointly
- 8 establish a conservation commission the members shall be
- 9 appointed in the same manner, by each of the respective
- 10 political subdivisions establishing the commission, each
- 11 constituent political subdivision to have equal membership on
- 12 the joint commission. Duly appointed commission members shall
- 13 serve for a term of three years except that initial appointments
- 14 shall be so staggered that the terms of approximately one-third
- 15 of the membership will expire each year, the terms of their
- 16 successors to be of three years each. Members shall receive no
- 17 compensation for their services, but shall be reimbursed for the
- 18 expenses actually and necessarily incurred by them in the
- 19 performance of their duties. The appointing authority shall
- 20 designate the chairman of the commission except that in joint
- 21 commissions the chairman will be elected by the duly selected
- 22 members. Whenever possible, one member shall also be a member of
- 23 the municipal planning board.
- 24 IF AN EXISTING PARK AND/OR RECREATION BOARD IS REDESIGNATED
- 25 AS THE PARK, RECREATION AND CONSERVATION COMMISSION, THE
- 26 MEMBERSHIP MAY BE INCREASED TO NOT MORE THAN ELEVEN.
- 27 Section 3. A conservation commission organized under this
- 28 act shall have power to develop plans and programs for the
- 29 promotion and conservation of the natural resources and for the
- 30 protection and improvement of the quality of the environment

- 1 within its territorial limits; to conduct research into the use
- 2 and possible use of the open land areas of the political
- 3 subdivision or political subdivisions within its territorial
- 4 limits; to coordinate the activities of unofficial bodies
- 5 organized for similar purposes; to advertise, prepare, print and
- 6 distribute books, maps, charts, plans and pamphlets as necessary
- 7 for its purposes; to keep an index of all open areas, publicly
- 8 or privately owned, including open marshlands, swamps and other
- 9 wetlands and waters for the purpose of obtaining information on
- 10 the proper use of such areas; and to recommend from time to time
- 11 to the planning commission or, if none, to the chief executive
- 12 officer or officers, or to the governing body or bodies plans
- 13 and programs for the implementation of such purposes.
- 14 Subject to the approval of the governing body or bodies
- 15 within its territorial limits, a conservation commission may
- 16 acquire property, both real and personal, in the name of the
- 17 political subdivision or political subdivisions, by gift,
- 18 purchase, grant, bequest, easement devise or lease for any of
- 19 its purposes and shall administer the same for such purposes
- 20 subject to the terms of the conveyance, gift or lease.
- 21 A CONSERVATION COMMISSION SHALL NOT EXERCISE ANY POWERS OR
- 22 PERFORM ANY DUTIES WHICH BY LAW ARE CONFERRED OR IMPOSED UPON A
- 23 STATE AGENCY.
- 24 Section 4. A conservation commission shall keep records of
- 25 its meetings and activities and shall make an annual report
- 26 which shall be printed in the annual municipal report or, if
- 27 none, otherwise made known and available.
- 28 Section 5. The governing body of any political subdivision
- 29 establishing a conservation commission may appropriate funds for
- 30 the expenses incurred by the conservation commission.

- 1 Appropriations may be expended for such administrative, clerical
- 2 and legal services as may from time to time be required and as
- 3 shall be within the limit of funds appropriated to the
- 4 conservation commission. The whole or any part of any funds so
- 5 appropriated in any year may be placed in a conservation fund,
- 6 allowed to accumulate from year to year, or be expended in any
- 7 year.
- 8 Section 6. Nothing in this act shall be construed to require
- 9 a political subdivision which has heretofore constituted a shade
- 10 tree commission or its counterpart to abolish such commission,
- 11 and any such commission heretofore established may continue to
- 12 operate as originally established.
- 13 Section 7. The Secretary of the Department of Environmental
- 14 Resources, in cooperation with the Secretary of the Department
- 15 of Community Affairs, shall establish a program of assistance to
- 16 conservation commissions with and through county conservation
- 17 districts in acquiring land and in planning for its protection,
- 18 management use and development. Such a program shall include,
- 19 but shall not be limited to educational services, exchange of
- 20 information, assignment of technical personnel for natural
- 21 resource planning assistance, and the coordination of State and
- 22 local conservation activities.
- 23 Section 8. This act shall take effect immediately.
