AN ACT

Amending the act of June 1, 1956 (P.L.1959, No.657), entitled, 2 as amended, "An act fixing the salaries and compensation of 3 the Chief Justice and judges of the Supreme Court, the President Judge and judges of the Superior Court, the judges 5 of the courts of common pleas, the judges of the orphans' 6 courts, the judges of the County Court of Philadelphia and 7 the judges of the County Court and Juvenile Court of 8 Allegheny County, certain associate judges not learned in the law, certain state officers, and the salary and expenses of 9 the members of the General Assembly, and repealing certain 10 inconsistent acts," further regulating expenses of judges 11 12 called to assist in another district. 13 The General Assembly of the Commonwealth of Pennsylvania 14 hereby enacts as follows: 15 Section 1. Section 10 of the act of June 1, 1956 (P.L.1959, No.657), entitled, as amended, "An act fixing the salaries and 16 compensation of the Chief Justice and judges of the Supreme 17 Court, the President Judge and judges of the Superior Court, the 18 19 judges of the courts of common pleas, the judges of the orphans' courts, the judges of the County Court of Philadelphia and the 20 judges of the County Court and Juvenile Court of Allegheny 21 22 County, certain associate judges not learned in the law, certain

- 4 Section 10. When any judge learned in the law is called in,
- 5 as is now provided by law, to assist the judge or judges of any
- 6 other judicial district, the judge so called in shall be
- 7 entitled to receive, for each day he is actually engaged in the
- 8 performance of such duty, the actual expenses not in excess of

- 9 the sum of fifty dollars (\$50) per day and the actual traveling
- 10 expenses not in excess of [ten cents (10¢)] twelve cents (12¢)
- 11 <u>FIFTEEN CENTS (15 \mathcal{C})</u> for each mile traveled to and from the place <—
- 12 of holding court in such district. THE PROVISIONS HEREOF SHALL
- 13 <u>IN NO WAY AFFECT THE RIGHT OF ANY SUCH JUDGE TO THE PAY PROVIDED</u>
- 14 BY LAW FOR HIS SERVICES IN THIS CAPACITY.
- 15 Section 2. This act shall take effect immediately.
