## AN ACT

Amending the act of September 29, 1961 (P.L.1745, No.708), entitled, as amended, "An act to define, license and regulate 3 resident and nonresident auctioneers in this Commonwealth, and revising, consolidating and making the law uniform 5 relative thereto; conferring certain powers and duties on the Board of Auctioneer Examiners, the Commissioner of 7 Professional and Occupational Affairs, the Secretary of the 8 Commonwealth and on certain other departments and officers of 9 the State; providing for the keeping of records and the inspection thereof; repealing certain inconsistent laws, and 10 providing penalties," prohibiting the sale of real estate by 11 auctioneers or apprentices unless they have a real estate 12 13 broker's license and providing penalties. 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Section 28, act of September 29, 1961 (P.L.1745, No.708), known as "The Auctioneers' License Act," reenacted and 17 18 amended June 15, 1972 (P.L.399, No.119), is amended to read: 19 Section 28. Unlawful [Act] Acts.--(a) It shall be unlawful 20 for any licensed auctioneer or apprentice auctioneer to pay any 21 compensation in money or other valuable thing to any person 22 other than a licensed auctioneer or apprentice auctioneer for 23 the rendering of any service or the doing of any of the acts by

- 1 this act forbidden to be rendered or performed by other than
- 2 licensees.
- 3 (b) No apprentice auctioneer shall accept or receive
- 4 compensation of any kind from any person other than the licensed
- 5 auctioneer by whom he is employed for any service rendered or
- 6 work done by him as an apprentice in the discharge of his
- 7 duties.
- 8 (c) [The violation of the provisions of this section by any
- 9 licensee shall be sufficient cause for the suspension or
- 10 revocation of his license in the discretion of the board.] No
- 11 <u>licensed auctioneer or apprentice auctioneer shall be entitled</u>
- 12 to sell real estate for compensation without being licensed as a
- 13 <u>real estate broker pursuant to law.</u>
- 14 (d) It shall be unlawful for any licensed auctioneer or
- 15 apprentice auctioneer to bid and buy for himself at any auction
- 16 he is conducting.
- 17 <u>(e)</u> The violation of any of the provisions of this section
- 18 by any licensee shall be sufficient cause for the suspension or
- 19 revocation of his license in the discretion of the board.
