| 23 | The General Assembly of the Commonwealth of Pennsylvania |
| 24 | hereby enacts as follows: |
| 25 | Section 1. Section 421, act of April 9, 1929 (P.L.177, |

| 26 | No.175), known as "The Administrative Code of 1929," amended May |
| 27 | 2, 1949 (P.L.781, No.193), is amended to read: |
| 28 | Section 421. State Board of Examiners of Public |

Accountants.--The State Board of Examiners of Public Accountants 1 shall consist of [the Superintendent of Public Instruction, and 2 3 five members, two of whom shall be appointed from the eastern 4 part of the State, two from the western part, and one from the 5 central part. Three of them shall be certified public accountants, holding degrees of the same from the Commonwealth 6 7 of Pennsylvania. The other two shall be practicing attorneys, in good standing in any of the courts of the Commonwealth. 8

9 The terms of the members of the board shall be four years 10 from the respective dates of their appointment.

11 Three members of the board shall constitute a quorum.

The board shall select, from among their number, a chairman, 12 13 and shall elect a secretary who need not be a member of the board. 14

15 Each member of the board, other than the Superintendent of 16 Public Instruction, shall receive fifteen dollars per diem, when 17 actually engaged in the work of the board, and the secretary 18 shall receive such reasonable compensation as the board shall determine, with the approval of the Superintendent of Public 19 20 Instruction.] eight members, one of whom shall be the 21 Commissioner of Professional and Occupational Affairs in the 22 Department of State and the seven remaining members shall be 23 appointed by the Governor as follows:

24 (1) six members shall be certified public accountants who 25 have held certificates of certified public accountant issued by 26 this Commonwealth for at least ten years immediately preceding 27 their appointment, all of whom are holders of live permits as 28 required under the act of May 26, 1947 (P.L.318, No.140), known 29 as "The C.P.A. Law," and four of whom have been actively engaged in the practice of public accounting as their principal 30 19750H1418B1667
