AN ACT

Amending the act of June 19, 1931 (P.L.589, No.202), entitled, 1 2 as amended, "An act to promote the public health and safety, 3 by providing for the examination and licensure of those who 4 desire to engage in the occupation of barbering; regulating 5 barber shops and barber schools, and apprentices and students therein; regulating compensation for service rendered; 6 7 conferring certain powers and duties on the Department of 8 Public Instruction; and providing penalties, " removing a 9 limitation in displaying a price list for services.

10 The General Assembly of the Commonwealth of Pennsylvania

11 hereby enacts as follows:

12 Section 1. Section 9, act of June 19, 1931 (P.L.589, 13 No.202), entitled, as amended, "An act to promote the public 14 health and safety, by providing for the examination and 15 licensure of those who desire to engage in the occupation of 16 barbering; regulating barber shops and barber schools, and 17 apprentices and students therein; regulating compensation for 18 service rendered; conferring certain powers and duties on the 19 Department of Public Instruction; and providing penalties," 20 amended July 19, 1961 (P.L.796, No.351), is amended to read: 21 Section 9. The board may suspend or revoke any permit or 22 certificate of registration granted by the department under this

act to any person who (a) habitually indulges in the use of 1 ardent spirits, narcotics, or other stimulants to such an extent 2 3 as, in the opinion of the board, incapacitates such person from 4 the duties of a barber; (b) has or imparts any contagious or 5 infectious disease to any recipient of such person's services as a barber; (c) performs work in an unsanitary or filthy manner or 6 7 place of business; (d) who is grossly incompetent; (e) who 8 conducts his business of barbering on Sundays; [(f) who displays 9 any price list for barber services in or upon any part of 10 premises of a barber shop in such manner that such list shall be 11 visible from the outside of the barber shop;] (g) engages in unethical or dishonest practice or conduct (h) or employs an 12 13 unlicensed person. Before any such permit or certificate shall 14 be suspended or revoked for any of the reasons contained in this 15 section, the holder thereof shall have notice in writing of the 16 charge or charges against him or her, and shall at a day 17 specified in said notice, which shall be at least five days 18 after the service thereof, be given a public hearing before a 19 duly authorized representative of the board with a full 20 opportunity to produce testimony in his or her behalf and to 21 confront the witnesses against him or her. Any person whose 22 permit or certificate of registration has been so suspended or revoked may, on application, have the same reissued to him or 23 24 her upon satisfactory showing that the disqualification has 25 ceased, except where such certificate was suspended or revoked for having or imparting any contagious or infectious disease in 26 27 which case a new certificate shall not be issued for a period of at least one year, and then only after the provisions of this 28 29 act have been fully complied with by such person in the same 30 manner as if he or she had never been registered.
