## AN ACT

- 17 Section 9. On and after the effective date of this act,
- 18 those portions of routes 62022, 62035 and 62133 deleted in whole
- 19 or in part by section 8, shall be maintained, constructed and
- 20 reconstructed, including all structures, by Washington County.
- 21 Such routes or portions of routes shall revert to Washington
- 22 County in their existing condition.
- 23 Section 10. This act shall take effect in 60 days.
