AN ACT

- 1 Providing for the regulation of smoking in public places and at 2 public meetings, and providing a penalty.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short Title. -- This act shall be known and may be
- 6 cited as the "Smoking Regulation Act."
- 7 Section 2. Definitions.--As used in this act:
- 8 "Public meeting" means a meeting open to the public.
- 9 "Public place" means any enclosed, indoor area used by the
- 10 general public or serving as a place of work, including, but not
- 11 limited to, restaurants, retail stores, offices and other
- 12 commercial establishments, public conveyances, educational
- 13 facilities, hospitals, nursing homes, auditoriums, arenas and
- 14 meeting rooms. It shall not include enclosed areas occupied
- 15 exclusively by smokers even though such areas may be visited by
- 16 nonsmokers.
- 17 Section 3. Police Power.--The Commonwealth of Pennsylvania
- 18 declares the passage of this act to be a valid exercise of its

- 1 police powers to protect the right of the nonsmoking public to
- 2 be free from the discomfort of smoke in public places and at
- 3 public meetings.
- 4 Section 4. Prohibitions.--No person shall smoke in a public
- 5 place or at a public meeting except in designated smoking areas.
- 6 This prohibition shall not apply in cases where an entire room
- 7 or hall is used for a private social function and seating
- 8 arrangements are under the control of the sponsor of the
- 9 function and not under the control of the proprietor or person
- 10 in charge of the place. This prohibition shall not apply to
- 11 factories, warehouses and similar places of work not usually
- 12 frequented by the general public, except that the Department of
- 13 Labor and Industry shall establish rules to restrict or prohibit
- 14 smoking in those places of work where the close proximity of
- 15 workers or the inadequacy of ventilation causes smoke pollution
- 16 detrimental to the health and comfort of nonsmoking employees.
- 17 Section 5. Inclusion. -- Smoking includes a carrying a lighted
- 18 cigar, cigarette, pipe, or any other lighted smoking equipment.
- 19 Section 6. Designation of Smoking Areas.--(a) Smoking areas
- 20 shall be designated by proprietors or other persons in charge of
- 21 public places, except where smoking is prohibited by the fire
- 22 marshal or by other law, ordinance or regulation.
- 23 (b) Where smoking areas are designated, existing physical
- 24 barriers and ventilation systems shall be used to minimize the
- 25 toxic effect of smoke in adjacent nonsmoking areas. When a
- 26 public place consists of a single room, the provisions of this
- 27 law shall be considered met if one side of the room is reserved
- 28 and posted as a no-smoking area. No public place other than a
- 29 bar shall be designated as a smoking area in its entirety. When
- 30 a bar is designated as a smoking area in its entirety, this

- 1 designation shall be posted conspicuously on all entrances
- 2 normally used by the public.
- 3 Section 7. Responsibilities of Proprietors.--The proprietor
- 4 or other person in charge of a public place shall make
- 5 reasonable efforts to prevent smoking in the public place by
- 6 posting appropriate signs, arranging seating to provide a smoke-
- 7 free area, asking smokers to refrain from smoking upon request
- 8 of a client or employee suffering discomfort from the smoke.
- 9 Section 8. Penalty. -- A person violating the provisions of
- 10 this act shall be guilty of a summary offense.
- 11 Section 9. Effective Date. -- This act shall take effect in 60
- 12 days.
