## AN ACT

1 2 3 4 5 6 7 8	Amending the act of May 7, 1923 (P.L.158, No.119), entitled "An act creating a Legislative Reference Bureau; providing for the election of a director by the General Assembly; designating the officers and employes of such bureau, defining their duties; fixing their salaries; abolishing the present Legislative Reference Bureau; and making an appropriation," establishing the Office of Revisor of Statutes and further providing for its powers and duties and making an appropriation.
10	The General Assembly of the Commonwealth of Pennsylvania
11	hereby enacts as follows:
12	Section 1. The act of May 7, 1923 (P.L.158, No.119),
13	entitled "An act creating a Legislative Reference Bureau;
14	providing for the election of a director by the General
15	Assembly; designating the officers and employes of such bureau,
16	defining their duties; fixing their salaries; abolishing the
17	present Legislative Reference Bureau; and making an
18	appropriation, " is amended by adding sections to read:
19	Section 10.1. Revisor of Statutes There shall be within
20	the Legislative Reference Bureau an Office of Revisor of
21	Statutes. This office shall consist of a revisor and such
22	technical, clerical, and stenographic personnel as necessary to

- 1 expeditiously and efficiently discharge the duties imposed by
- 2 this act.
- 3 <u>Section 10.2. Appointment of Personnel; Qualifications;</u>
- 4 Salary. -- In connection with the operations of the Revisor of
- 5 Statutes, the Director of the Legislative Reference Bureau shall
- 6 <u>select as Revisor of Statutes a duly qualified person. The</u>
- 7 revisor shall have direct supervision and control of the office.
- 8 The revisor, with the approval of the Director of the
- 9 <u>Legislative Reference Bureau, may select such assistant revisors</u>
- 10 as may be required for the proper discharge of the functions of
- 11 the office. The revisor, with similar approval, shall also
- 12 <u>select other technical, clerical and stenographic assistants as</u>
- 13 <u>may be necessary</u>.
- 14 The revisor's salary shall be set by the Director of the
- 15 Legislative Reference Bureau at not less than twenty thousand
- 16 <u>dollars a year. The salary of the assistant revisors shall be</u>
- 17 set by the revisor with the approval of the Director of the
- 18 Legislative Reference Bureau.
- 19 Section 10.3. Powers and Duties.--The Revisor of Statutes
- 20 <u>shall have the power and duty to:</u>
- 21 (1) Select such statutory law as are considered most in need
- 22 of revision and present to the General Assembly bills covering
- 23 such revisions.
- 24 (2) Recommend the revision, simplification and rearrangement
- 25 <u>of existing statutory law.</u>
- 26 (3) Eliminate from such law all obsolete, superseded,
- 27 duplicated and unconstitutional statutes or parts of statutes,
- 28 but make no changes in the substance of existing statutes.
- 29 (4) Furnish the General Assembly explanatory statements of
- 30 changes in existing statutes or parts of statutes which such

- 1 revisions, if enacted, would accomplish.
- 2 (5) Conduct a mandatory review of existing statutes every
- 3 <u>ten years.</u>
- 4 (6) Conduct a mandatory review of all laws relating to the
- 5 boards, departments, agencies, commissions and bureaus of the
- 6 Executive Branch of the government every five years.
- 7 (7) Perform such other actions as are necessary to carrying
- 8 out the provisions of this section.
- 9 <u>Section 10.4. Appropriation.--The sum of one hundred twenty-</u>
- 10 five thousand dollars, or as much thereof as may be necessary,
- 11 <u>is specifically appropriated to the Legislative Reference Bureau</u>
- 12 for the fiscal year July 1, 1976 to June 30, 1977 to establish
- 13 and staff the Office of the Revisor of Statutes.
- 14 Section 2. This act shall take effect in 60 days.
