In the House of Representatives, March 18, 1975

- 1 WHEREAS, The General Assembly of the Commonwealth enacted
- 2 legislation on August 14, 1963 permitting the establishment of
- 3 metropolitan transportation authorities to alleviate the
- 4 transportation problems and difficulties of metropolitan areas;
- 5 and
- 6 WHEREAS, The Southeastern Pennsylvania Transportation
- 7 Authority was formed on or about February 18, 1964 in accordance
- 8 with the provisions of the "Metropolitan Transportation
- 9 Authorities Act of 1963"; and
- 10 WHEREAS, A multitude of serious concerns and troubling
- 11 questions have arisen concerning the purpose, funding,
- 12 management and operations of the Southeastern Pennsylvania
- 13 Transportation Authority; therefore be it
- 14 RESOLVED, That the Speaker of the House of Representatives
- 15 appoint a seven member bipartisan committee, four from the
- 16 majority and three from the minority, to study and investigate
- 17 the questions and concerns of the public relating to the

- 1 Southeastern Pennsylvania Transportation Authority with a view
- 2 to improving the same; and be it further
- RESOLVED, That the committee may hold hearings, take
- 4 testimony, and make its investigations at such places as it
- 5 deems necessary within this Commonwealth. It may issue subpoenas
- 6 under the hand and seal of its chairman commanding any person to
- 7 appear before it and to answer questions touching matters
- 8 properly being inquired into by the committee and to produce
- 9 such books, papers, records and documents as the committee deems
- 10 necessary. Such subpoenas may be served upon any person and
- 11 shall have the force and effect of subpoenas issued out of the
- 12 courts of this Commonwealth. Any person who wilfully neglects or
- 13 refuses to testify before the committee or to produce any books,
- 14 papers, records or documents, shall be subject to the penalties
- 15 provided by the laws of the Commonwealth in such case. Each
- 16 member of the committee shall have power to administer oaths and
- 17 affirmations to witnesses appearing before the committee; and be
- 18 it further
- 19 RESOLVED, That within thirty calendar days after the
- 20 committee has made its report, the chairman of the committee
- 21 shall cause a record of all expenses incurred by the committee,
- 22 or the members thereof, which are payable at Commonwealth
- 23 expense, to be filed with the Speaker of the House of
- 24 Representatives and the Speaker shall cause the same to be
- 25 entered in the journal thereof. No expenses incurred by the
- 26 committee or any member thereof shall be reimbursable by the
- 27 Chief Clerk unless such expense shall first have been included
- 28 as an expense item in the record heretofore required; and be it
- 29 further
- RESOLVED, That the committee report back as soon as its study

- 1 and investigation are completed together with its findings and
- 2 recommendations.
