AN ACT

Amending the act of December 15, 1959 (P.L.1779, No.673), entitled, as amended, "An act relating to fish, frogs, tadpoles and turtles; and amending, revising and 3 consolidating and changing the law relating to fish in the 5 inland waters and the boundary lakes and boundary rivers of 6 the Commonwealth, " changing the minimal age for which a 7 resident and nonresident fishing license is required and 8 changing the license fees. The General Assembly of the Commonwealth of Pennsylvania 10 hereby enacts as follows: 11 Section 1. Subsection (a) of section 220, act of December 15, 1959 (P.L.1779, No.673), known as "The Fish Law of 1959," 12 13 amended July 24, 1973 (P.L.196, No.47), is amended to read: 14 Section 220. Resident Fishing License; Fees. -- (a) For the 15 purposes of this article, every person sixteen years of age and 16 upward, upon application to any issuing agent within the Commonwealth, or to the Commission, and upon the establishment 17 18 of his identity and age to the satisfaction of the issuing agent or the Commission by producing a [bank book, letters, lodge 19 cards, police cards, a] motor vehicle operator's permit or some 20 21 other positive means of identification and age, that he has been

- 1 a bona fide resident of this Commonwealth [for a period of sixty
- 2 days next preceding his application and was born in the United
- 3 States, and in the case of naturalized foreign-born residents,
- 4 the production of such applicant's naturalization papers, or a
- 5 member of the Armed Forces of the United States who is on full-
- 6 time active duty and permanently assigned to a military
- 7 <u>installation located within the Commonwealth</u> shall, upon the
- 8 payment to the issuing agent or the Commission of a license fee
- 9 of [seven dollars fifty cents (\$7.50)] <u>nine dollars (\$9.00)</u>
- 10 except as hereinafter provided for persons sixty-five years of
- 11 age and over for the use of the Commonwealth, and in the event
- 12 that the license is issued by an issuing agent, a fee of twenty-
- 13 five cents (25¢) for the use of the issuing agent, be entitled
- 14 to the license herein referred to as a "resident fishing
- 15 license." Residents with the above qualifications, who are
- 16 sixty-five or more years of age at the time of application,
- 17 shall be entitled to a <u>"senior</u> resident fishing license" upon
- 18 payment to said agent or the Commission of a license fee of two
- 19 dollars (\$2.00) for the use of the Commonwealth, and in the
- 20 event that the license is issued by an issuing agent, a fee of
- 21 twenty-five cents (25¢) for the use of the issuing agent. The
- 22 license in such cases shall, in addition to the other
- 23 information required, give the date of birth of the applicant.
- 24 Section 2. Section 220 of the act is amended by adding a
- 25 subsection to read:
- 26 Section 220. Resident Fishing License; Fees. -- * * *
- 27 (a.1) For the purposes of this article every person who is
- 28 twelve years of age but who has not reached sixteen years of
- 29 age, upon application to any issuing agent within the
- 30 Commonwealth, or to the Commission, and upon the establishment

- 1 of his identity and age to the satisfaction of the issuing agent
- 2 or the Commission by some positive means of identification and
- 3 age, that he is a bona fide resident of this Commonwealth, shall
- 4 upon payment to the issuing agent or the Commission of a license
- 5 fee of three dollars (\$3.00) for the use of the Commonwealth,
- 6 and in the event that the license is issued by an issuing agent,
- 7 a fee of twenty-five cents (25c) for the use of the issuing
- 8 agent, be entitled to the license herein referred to as a
- 9 <u>"junior fishing license."</u>
- 10 * * *
- 11 Section 3. The section heading and subsections (a) and (b)
- 12 of section 221 of the act, subsections (a) and (b) amended July
- 13 24, 1973 (P.L.196, No.47), are amended to read:
- 14 Section 221. Nonresident [and Alien Nonresident] Fishing
- 15 License Fees; Tourist Fishing License Fees for Nonresidents [and
- 16 Alien Nonresidents].--(a) For the purposes of this article,
- 17 every person, sixteen years of age and upward, upon application
- 18 to any issuing agent within the Commonwealth or to the
- 19 Commission [and the presentation of proof that he is an alien or
- 20 a nonresident of this Commonwealth], shall, upon the payment to
- 21 the issuing agent or the Commission of the sum of [twelve
- 22 dollars fifty cents (\$12.50)] fourteen dollars (\$14.00), and in
- 23 the event the license is issued by an issuing agent, the payment
- 24 of twenty-five cents (25¢) for the use of the issuing agent, be
- 25 entitled to the license herein referred to as a "nonresident
- 26 fishing license." Nonresidents who are twelve years of age but
- 27 who have not reached sixteen years of age shall be entitled to a
- 28 "junior fishing license" upon the payment to said issuing agent
- 29 or to the Commission of a license fee of three dollars (\$3.00)
- 30 and in the event that the license is issued by an issuing agent,

- 1 the payment of a fee of twenty-five cents (25¢) for the use of
- 2 the agent.
- 3 (b) For the purposes of this article, every person, sixteen
- 4 years of age and upward, upon application to any issuing agent
- 5 within the Commonwealth, or to the Commission [and the
- 6 presentation of proof that he is a nonresident of the
- 7 Commonwealth], shall, upon the payment to the issuing agent or
- 8 the Commission a license fee of [seven dollars fifty cents
- 9 (\$7.50)] <u>nine dollars (\$9.00)</u> for the use of the Commonwealth,
- 10 and in the event that the license is issued by an issuing agent,
- 11 a fee of twenty-five cents (25¢) for the use of the issuing
- 12 agent, be entitled to the license herein referred to as a
- 13 "tourist fishing license," which shall be valid for a period of
- 14 seven consecutive days.
- In case the license certificate is lost or destroyed, a new
- 16 license may be secured from the Commission upon making affidavit
- 17 to that effect and the payment of a fee of fifty cents (50¢).

- 19 Section 4. This act shall take effect January 1, 1978.
