Section 17. It shall be the duty of every person who shall 9 10 employ any minor under eighteen years of age to acknowledge, in 11 writing, to the official issuing the same, the receipt of the employment certificate of said minor, within five days after the 12 13 beginning of such employment. On termination of the employment 14 of a minor under eighteen years of age, the employment 15 certificate issued for such minor shall be returned by mail, by the employer, to the official issuing the same, immediately upon 16 17 demand of the minor for whom the certificate was issued, or 18 otherwise, within five days after termination of said 19 employment. The official to whom said certificate is so returned shall file said certificate and preserve the same. Any minor 20 21 whose employment certificate has been returned, as above 22 provided, shall be entitled to a new employment certificate upon 23 presentation of a statement from the prospective employer, as hereinabove provided[, accompanied by a certificate of physical 24 25 fitness, issued in the manner hereinabove provided and based 26 upon a reexamination of said minor, and certifying that the minor is physically able to undertake the work for which the new 27 28 employment certificate is to be issued].

29 Section 4 2. This act shall take effect immediately.
