AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, including ambulances within the operating rules
- 3 relating to other emergency vehicles.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3105 of Title 75, act of November 25,
- 7 1970 (P.L.707, No.230), known as the Pennsylvania Consolidated
- 8 Statutes, added June 17, 1976 (P.L.162, No.81), is amended to
- 9 read:
- 10 § 3105. Drivers of emergency vehicles.
- 11 (a) General rule. -- The driver of an emergency vehicle, when
- 12 responding to an emergency call or when in the pursuit of an
- 13 actual or suspected violator of the law or when responding to
- 14 but not upon returning from a fire alarm, may exercise the
- 15 privileges set forth in this section, but subject to the
- 16 conditions stated in this section.
- 17 (b) Exercise of special privileges.--The driver of an
- 18 emergency vehicle may:

- 1 (1) Park or stand, irrespective of the provisions of
- 2 this part.
- 3 (2) Proceed past a red signal indication or stop sign,
- 4 but only after slowing down as may be necessary for safe
- operation, except as provided in subsection (d).
- 6 (3) Exceed the maximum speed limits so long as the
- 7 driver does not endanger life or property, except as provided
- 8 in subsection (d).
- 9 (4) Disregard regulations governing direction of
- 10 movement or turning in specified directions.
- 11 (c) Audible and visual signals required.--The privileges
- 12 granted in this section to an emergency vehicle shall apply only
- 13 when the vehicle is making use of an audible signal and visual
- 14 signals meeting the requirements and standards set forth in
- 15 regulations adopted by the department, except that an emergency
- 16 vehicle operated as a police vehicle need not be equipped with
- 17 or display the visual signals.
- 18 (d) [Ambulances and blood-delivery] Blood-delivery
- 19 vehicles.--The driver of [an ambulance or] <u>a</u> blood-delivery
- 20 vehicle shall comply with maximum speed limits, red signal
- 21 indications and stop signs. After ascertaining that the
- 22 [ambulance or] blood-delivery vehicle will be given the right-
- 23 of-way, the driver may proceed through a red signal indication
- 24 or stop sign.
- 25 (e) Exercise of care. -- This section does not relieve the
- 26 driver of an emergency vehicle from the duty to drive with due
- 27 regard for the safety of all persons.
- 28 Section 2. This act shall take effect immediately or July 1,
- 29 1977, whichever is later.
