## AN ACT

Amending the act of June 3, 1937 (P.L.1333, No.320), entitled "An act concerning elections, including general, municipal, 3 special and primary elections, the nomination of candidates, primary and election expenses and election contests; creating 5 and defining membership of county boards of elections; 6 imposing duties upon the Secretary of the Commonwealth, 7 courts, county boards of elections, county commissioners; imposing penalties for violation of the act, and codifying, 8 9 revising and consolidating the laws relating thereto; and repealing certain acts and parts of acts relating to 10 elections," providing that all county election officers 11 receive compensation based on the same rate schedules and 12 making editorial changes. 13 14 The General Assembly of the Commonwealth of Pennsylvania 15 hereby enacts as follows: 16 Section 1. Subsection (a) of section 412, act of June 3, 1937 (P.L.1333, No.320), known as the "Pennsylvania Election 17 18 Code, " is repealed. 19 Section 2. Subsection (b) of section 412 of the act, amended 20 December 2, 1976 (P.L.1221, No.269), is reenacted to read: Section 412. Compensation of Election Officers. -- \* \* \* 21 22 In all counties the compensation of judges, inspectors,

clerks and machine inspectors shall be fixed by the county board

- 1 of elections of the county at not less than the following:
- 2 judges of election, forty-five dollars (\$45.00); inspectors and
- 3 clerks, forty dollars (\$40.00); and machine operators, forty
- 4 dollars (\$40.00); and not more than the following: judges of
- 5 election, sixty dollars (\$60.00); inspectors and clerks, fifty-
- 6 five dollars (\$55.00); and machine operators, fifty-five dollars
- 7 (\$55.00); for each primary and election. The county board of
- 8 elections may, in its discretion, establish different per diem
- 9 rates within the above mentioned minima and maxima based on the
- 10 number of votes cast for the following groups: 150 votes or
- 11 less, 151 to 500 votes, 501 to 1000 votes, over 1000 votes.

- 13 Section 3. Section 1207 of the act, amended July 1, 1976
- 14 (P.L.523, No.124), is amended to read:
- 15 Section 1207. Peace Officers; No Police Officer to Be Within
- 16 One Hundred Feet of Polling Place; Exceptions; Presence of
- 17 Soldiers Prohibited. -- The constable of each borough, township or
- 18 ward, or his deputy shall be present at the polling place in
- 19 each election district of such borough, township or ward at each
- 20 primary and election during the continuance thereof, and while
- 21 the votes are being counted, for the purpose of preserving the
- 22 peace, and shall serve at all elections for which services the
- 23 said constable and each of such deputies performing such
- 24 services shall receive the [same] sum of twenty-five dollars
- 25 (\$25.00) as compensation [payable to inspectors and clerks under
- 26 section 412 (a) of this act] which shall be paid by the county.
- 27 Such sum shall include pay for serving notices in writing to
- 28 persons elected at such election. The election officers, or any
- 29 three qualified electors of any election district, may call upon
- 30 any mayor, chief burgess, sheriff, deputy sheriff, constable,

- 1 deputy constable, or police officer, to clear an avenue to the
- 2 door of any polling place which is obstructed in such a way as
- 3 to prevent electors from approaching, or to maintain order and
- 4 quell any disturbance, if such arises. No police officer in
- 5 commission, whether in uniform or in citizen's clothes, shall be
- 6 within one hundred feet of a polling place during the conduct of
- 7 any primary or election, unless in the exercise of his privilege
- 8 of voting, or for the purpose of serving warrants, or unless
- 9 called upon to preserve the peace, as provided by this act:
- 10 Provided, however, That such prohibition shall not apply to such
- 11 police officers assigned to a police station or headquarters
- 12 located in a building or on the premises where the polling place
- 13 is located and such police officers must be within one hundred
- 14 (100) feet of the polling place to enter and exit such police
- 15 station or headquarters: And provided further, That in no event
- 16 may any police officer unlawfully use or practice any
- 17 intimidation, threats, force or violence nor, in any manner,
- 18 unduly influence or overawe any elector or prevent him from
- 19 voting or restrain his freedom of choice, nor may any such
- 20 police officer electioneer or directly or indirectly attempt to
- 21 influence the election or electors while within one hundred
- 22 (100) feet of a polling place as herein set forth: And provided
- 23 further, That where polling places are located in buildings or
- 24 on premises where a police station or headquarters are located,
- 25 the polling place shall be located in a separate room. No body
- 26 of troops in the Army of the United States or of this
- 27 Commonwealth shall be present, either armed or unarmed, at any
- 28 place of election within this Commonwealth during the time of
- 29 any primary or election: Provided, however, That no officer or
- 30 soldier shall be prevented from exercising the right of suffrage

- 1 in the election district in which he resides, if otherwise
- 2 qualified.
- 3 Section 4. This act shall take effect in 60 days.
