## AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or authorizing the reorganization of certain administrative 8 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 boards, commissions, and officers; fixing the salaries of the 12 13 Governor, Lieutenant Governor, and certain other executive 14 and administrative officers; providing for the appointment of 15 certain administrative officers, and of all deputies and other assistants and employes in certain departments, boards, 16 17 and commissions; and prescribing the manner in which the 18 number and compensation of the deputies and all other assistants and employes of certain departments, boards and 19 20 commissions shall be determined, " providing for the powers of 21 waterways patrolmen. 22 The General Assembly of the Commonwealth of Pennsylvania 23 hereby enacts as follows: 24 Section 1. Section 2706, act of April 9, 1929 (P.L.177, No.175), known as "The Administrative Code of 1929," is amended 26 to read: 27 Section 2706. Powers of [Fish Wardens] Waterways
- 28 Patrolmen. -- A full-time paid waterways patrolman shall have the

- 1 power to enforce all laws of this Commonwealth in an emergency.
- 2 Otherwise, he shall enforce only those laws pertaining to the
- 3 sphere of concern specified by the Pennsylvania Fish Commission.
- 4 The same limited power may be granted by the Pennsylvania Fish
- 5 Commission to part-time, unpaid deputy waterways patrolmen who
- 6 are paid law enforcement officers of the political subdivisions
- 7 of this Commonwealth. In addition, [Every] every member of the
- 8 Pennsylvania Fish Commission, every [fish warden] waterways
- 9 patrolman, and every special [fish warden] waterways patrolman
- 10 shall have power:
- 11 (a) To enforce all the laws of the Commonwealth relating to
- 12 fish;
- 13 (b) To execute all warrants and search warrants for the
- 14 violation of the fish laws;
- 15 (c) To serve subpoenas issued for the examination,
- 16 investigation, and trial of all offenses against the laws
- 17 relating to fish;
- 18 (d) To carry firearms, or other weapons, in the performance
- 19 of his duties, and to stop or halt, by pointing or discharging
- 20 firearms, any person violating or believed to be violating any
- 21 of the laws of the Commonwealth the enforcement of which is
- 22 charged to such officers, and any such officer shall at all
- 23 times be privileged to protect himself in the performance of his
- 24 duty;
- 25 (e) To search, without warrant, any boat, conveyance,
- 26 vehicle, fish-box, bag, coat, basket, or other receptacle for
- 27 fish, when he has reason to believe that any provision of any
- 28 law of this Commonwealth relating to fish has been violated;
- 29 (f) To seize and take possession of any and all fish which
- 30 may have been caught, taken, or killed at any time, in any

- 1 manner, or for any purpose, or had in possession, or under
- 2 control, or which have been shipped or are about to be shipped,
- 3 contrary to the laws of this Commonwealth. Fish so seized shall
- 4 be disposed of in any manner as the Executive Director of the
- 5 Commission may direct;
- 6 (g) To enter upon any land or water in the performance of
- 7 his duty;
- 8 (h) To demand and secure proper assistance in case of
- 9 emergency;
- 10 (i) To purchase fish for the purpose of securing evidence.
- 11 Section 2. The provisions of this act shall not be construed
- 12 to affect the rights of waterways patrolmen under the act of
- 13 July 23, 1970 (P.L.563, No.195), known as the "Public Employe
- 14 Relations Act."
- 15 Section 3. This act shall take effect in 30 days.
