## AN ACT

- Amending the act of December 22, 1977 (No.28A), entitled "A 2 supplement to the act of July 28, 1966 (3rd Sp.Sess., P.L.87, No.3), entitled 'An act providing for the establishment and 3 operation of the University of Pittsburgh as an 4 5 instrumentality of the Commonwealth to serve as a State-6 related university in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of trustees, and 7 8 9 the power and duties of such trustees; authorizing 10 appropriations in amounts to be fixed annually by the General 11 Assembly; providing for the auditing of accounts of 12 expenditures from said appropriations; providing for public 13 support and capital improvements; authorizing the issuance of 14 bonds exempt from taxation within the Commonwealth; requiring the chancellor to make an annual report of the operations of 15 16 the University of Pittsburgh,' making appropriations for 17 carrying the same into effect, providing for a basis for 18 payments of such appropriations, and providing a method of 19 accounting for the funds appropriated, " making an additional 20 appropriation upon approval of a reduction in the commissions 21 of cigarette tax stamping agencies. 22 The General Assembly of the Commonwealth of Pennsylvania 23 hereby enacts as follows: 24 Section 1. - 15 <u>Section 1.1. An additional appropriation in the sum of</u>
- 16 \$333,000 is hereby specifically appropriated to the Trustees of
- 17 the University of Pittsburgh for the fiscal year July 1, 1977 to
- 18 June 30, 1978 for use in meeting general expenses subject to the
- 19 <u>enactment and approval of legislation reducing the commissions</u>
- 20 of cigarette tax stamping agencies.
- 21 Section 2. This act shall take effect upon approval of a law
- 22 reducing the commissions of cigarette tax stamping agencies or
- 23 immediately whichever is later.
