AN ACT

- Amending the act of June 2, 1915 (P.L.736, No.338), entitled, as 2 amended, "An act defining the liability of an employer to pay damages for injuries received by an employe in the course of 3 4 employment; establishing an elective schedule of 5 compensation; providing procedure for the determination of liability and compensation thereunder and prescribing 6 7 penalties, " to provide for equal rights between widows and 8 widowers. 9 The General Assembly of the Commonwealth of Pennsylvania
- 10 hereby enacts as follows:
- 11 Section 1. Section 101, act of June 2, 1915 (P.L.736,
- 12 No.338), known as "The Pennsylvania Workmen's Compensation Act,"
- reenacted and amended June 21, 1939 (P.L.520, No.281) and 13
- 14 amended December 5, 1974 (P.L.782, No.263), is amended to read:
- 15 Section 101. That this act shall be called and cited as The
- 16 Pennsylvania [Workmen's] Worker's Compensation Act, and shall
- apply to all injuries occurring within this Commonwealth, 17
- irrespective of the place where the contract of hiring was made, 18
- 19 renewed, or extended, and extraterritorially as provided by

- 1 section 305.2.
- 2 Section 2. The second paragraph of section 307 of the act,
- 3 amended December 5, 1974 (P.L.782, No.263), is amended to read:
- 4 Section 307. * * *
- 5 Compensation shall be payable under this section to or on
- 6 account of any child, brother, or sister, only if and while such
- 7 child, brother, or sister, is under the age of eighteen unless
- 8 such child, brother or sister is dependent because of disability
- 9 when compensation shall continue or be paid during such
- 10 disability of a child, brother or sister over eighteen years of
- 11 age or unless such child is enrolled as a full-time student in
- 12 any accredited educational institution when compensation shall
- 13 continue until such student becomes twenty-three. No
- 14 compensation shall be payable under this section to a [widow]
- 15 <u>surviving spouse</u>, unless [she] <u>he</u> was living with [her] <u>his</u>
- 16 deceased [husband] spouse at the time of his death, or was then
- 17 actually dependent upon [him] the deceased spouse and receiving
- 18 from [him] <u>such deceased spouse</u> a substantial portion of [her]
- 19 <u>his</u> support. [No compensation shall be payable under this
- 20 section to a widower, unless he be incapable of self-support at
- 21 the time of his wife's death and be at such time dependent upon
- 22 her for support.] If members of decedent's household at the time
- 23 of his death, the terms "child" and "children" shall include
- 24 step-children, adopted children and children to whom he stood in
- 25 loco parentis, and shall include posthumous children. Should any
- 26 dependent or surviving spouse of a deceased employe die or
- 27 remarry, [or should the widower become capable of self-support,]
- 28 the right of such dependent [or widower] or surviving spouse to
- 29 compensation under this section shall cease except that if a
- 30 [widow] surviving spouse remarries, [she] he shall receive one

- 1 hundred four weeks compensation at a rate computed in accordance
- 2 with clause 2. of section 307 in a lump sum after which
- 3 compensation shall cease: Provided, however, That if, upon
- 4 investigation and hearing, it shall be ascertained that the
- 5 widow or widower is living with a man or woman, as the case may
- 6 be, in meretricious relationship and not married, [or the widow
- 7 living a life of prostitution,] the board may order the
- 8 termination of compensation payable to such widow or widower. If
- 9 the compensation payable under this section to any person shall,
- 10 for any cause, cease, the compensation to the remaining persons
- 11 entitled thereunder shall thereafter be the same as would have
- 12 been payable to them had they been the only persons entitled to
- 13 compensation at the time of the death of the deceased.

- 15 Section 3. Section 310 of the act is repealed.
- 16 Section 4. This act shall take effect in 60 days.
