## AN ACT

Amending the act of October 5, 1972 (Sp.Sess. No.1, P.L.2019, 2 No.4), entitled "An act implementing the provisions of clause (1) of subsection (a) of section 7 of Article VIII of the 3 Constitution of the Commonwealth of Pennsylvania authorizing 5 the incurring of debt for the rehabilitation of areas 6 affected by the Great Storm and Floods of September, 1971 and 7 June, 1972 through urban redevelopment assistance; imposing 8 duties upon the Governor, the Auditor General and State 9 Treasurer; prescribing the procedures for the issuance, sale and payment of general obligations bonds, the funding of debt 10 and refunding of bonds; exempting said bonds from State and 11 local taxation; creating certain funds; and making an 12 13 appropriation, " providing for the borrowing of an additional 14 sum to rehabilitate areas affected by the Great Flood of July, 1977. 15 16 The General Assembly of the Commonwealth of Pennsylvania 17 hereby enacts as follows: The title, act of October 5, 1972 (Sp.Sess. No.1, 18 Section 1. 19 P.L.2019, No.4), entitled "An act implementing the provisions of 20 clause (1) of subsection (a) of section 7 of Article VIII of the 21 Constitution of the Commonwealth of Pennsylvania authorizing the 22 incurring of debt for the rehabilitation of areas affected by 23 the Great Storm and Floods of September, 1971 and June, 1972 24 through urban redevelopment assistance; imposing duties upon the

- 20 (P.L.88, No.38), is amended to read:
- 21 Section 1. Borrowing of Money Authorized.--Pursuant to the
- 22 provisions of clause (1) of subsection (a) of section 7 of
- 23 Article VIII of the Constitution of the Commonwealth of
- 24 Pennsylvania, the Commonwealth is hereby authorized and directed
- 25 to borrow, from time to time, money not exceeding in the
- 26 aggregate (i) the sum of one hundred forty million dollars
- 27 (\$140,000,000), as may be found necessary to carry out the
- 28 rehabilitation of areas affected by the Great Storm and Floods
- 29 of September, 1971 [and] , June, 1972 and July, 1977 through
- 30 urban redevelopment assistance, and (ii) the sum of thirty

- million dollars (\$30,000,000) as may be found necessary to carry 1
- 2 <u>out the rehabilitation of areas affected by the Great Flood of</u>
- 3 July, 1977 through urban redevelopment assistance.
- 4 Section 3. This act shall take effect immediately.
