## AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, authorizing attachment of
- 3 retirement allowances in cases of certain criminal conduct.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Subsection (b) of section 8124 of Title 42, act
- 7 of November 25, 1970 (P.L.707, No.230), known as the
- 8 Pennsylvania Consolidated Statutes, amended April 28, 1978
- 9 (No.53), is amended to read:
- 10 § 8124. Exemption of particular property.
- 11 \* \* \*
- 12 (b) Retirement funds and accounts. -- When a monetary judgment
- 13 has been secured against any present or former public employee
- 14 or public official based upon any criminal conduct of that
- 15 public employee or public official under color of or in

- 1 connection with any public office or public employment, the
- 2 judgment may be enforced through attachment or execution on a
- 3 judgment of that person's (i) retirement allowance, (ii)
- 4 contribution to the retirement fund, (iii) contributions to a
- 5 retirement fund returned to such person, and (iv) the moneys in
- 6 the retirement fund credited to such member. The following money
- 7 or other property of the judgment debtor shall be exempt from
- 8 attachment or execution on a judgment:
- 9 (1) Certain amounts payable under the Public School
- 10 Employees' Retirement Code as provided by 24 Pa.C.S. § 8533
- 11 (relating to taxation, attachment and assignment of funds).
- 12 (2) Certain amounts payable under the State Employees'
- Retirement Code as provided by 71 Pa.C.S. § 5953 (relating to
- taxation, attachment and assignment of funds).
- 15 (3) The retirement allowance provided for in the act of
- 16 May 24, 1893 (P.L.129, No.82).
- 17 (4) Compensation or pension provided for in the act of
- 18 May 20, 1915 (P.L.566, No.242).
- 19 (5) Compensation or pension provided for in the act of
- 20 May 28, 1915 (P.L.596, No.259).
- 21 (6) The retirement allowance, contributions and returned
- 22 contributions under the act of February 1, 1974 (P.L.34,
- No.15), known as the "Pennsylvania Municipal Retirement Law."
- 24 (7) Any pension or annuity, whether by way of a gratuity
- or otherwise, granted or paid by any private corporation or
- 26 employer to a retired employee under a plan or contract which
- 27 provides that the pension or annuity shall not be assignable.
- 28 (8) Any retirement or annuity fund of any self-employed
- 29 person (to the extent of payments thereto made while solvent,
- 30 but not exceeding the amount actually excluded or deducted as

- 1 retirement funding for Federal income tax purposes) and the
- 2 appreciation thereon, the income therefrom and the benefits
- 3 or annuity payable thereunder.

- 5 Section 2. This act shall take effect in 60 days.
