In the House of Representatives, November 21, 1977

- 1 RESOLVED, That the Speaker of the House of Representatives
- 2 appoint a five-member bipartisan committee, three from the
- 3 majority party and two from the minority party for the purpose
- 4 of investigating the mismanagement and fraud involving the
- 5 personnel and operation of the Department of Public Welfare; and
- 6 be it further
- 7 RESOLVED, That the committee may hold hearings, take
- 8 testimony, and make its investigations at such places as it
- 9 deems necessary. It may issue subpoenas under the hand and seal
- 10 of its chairman commanding any person to appear before it and to
- 11 answer questions touching matters properly being inquired into
- 12 by the committee and to produce such books, papers, records and
- 13 documents as the committee deems necessary. Such subpoenas may
- 14 be served upon any person and shall have the force and effect of
- 15 subpoenas issued out of the courts of this Commonwealth. Any
- 16 person who willfully neglects or refuses to testify before the

- 1 committee or to produce any books, papers, records or documents,
- 2 shall be subject to the penalties provided by the laws of the
- 3 Commonwealth in such case. Each member of the committee shall
- 4 have power to administer oaths and affirmations to witnesses
- 5 appearing before the committee; and be it further
- 6 RESOLVED, That within 30 calendar days after the committee
- 7 has made its report, the chairman of the committee shall cause a
- 8 record of all expenses incurred by the committee, or the members
- 9 thereof, which are payable at Commonwealth expense, to be filed
- 10 with the Speaker of the House and the Speaker shall cause the
- 11 same to be entered in the journal thereof. No expenses incurred
- 12 by the committee or any member thereof shall be reimbursable by
- 13 the Chief Clerk unless such expense shall first have been
- 14 included as an expense item in the record heretofore required;
- 15 and be it further
- 16 RESOLVED, That the committee report its finding and proposed
- 17 legislation, if such be necessary, to the General Assembly as
- 18 soon as possible.
