## AN ACT

Making an appropriation to the State Treasurer for the purpose of paying salaries and wages of State officers and employees 2 3 and other ordinary and general expenses in the interim between June 30, 1977 and August 1, 1977, and for the payment of bills incurred and remaining unpaid at the close of the fiscal year ending June 30, 1977. 7 The General Assembly of the Commonwealth of Pennsylvania 8 hereby enacts as follows. 9

- Section 1. The sum of \$160,016,000, or as much thereof as
- 10 may be necessary, is hereby specifically appropriated to the
- 11 State Treasurer of the Commonwealth of Pennsylvania for the
- 12 purpose of paying the salaries and wages of the officers and
- 13 employees and other ordinary and general expenses of the State
- government in the interim between June 30, 1977 and August 1, 14
- 15 1977, and for the payment of bills incurred and remaining unpaid
- at the close of the fiscal year ending June 30, 1977. The funds 16
- 17 provided by this act may be used for all preferred
- 18 appropriations of 1976-1977 but shall not be used for payment of
- 19 cash grants or medical assistance, or for payment of
- 20 appropriations to charitable or educational institutions not

- 1 under the absolute control of the Commonwealth.
- 2 Section 2. Payments out of the appropriation of this act
- 3 shall be made by the State Treasurer upon requisitions by the
- 4 several departments, boards, commissions or officers in the same
- 5 manner as payments are ordinarily made.
- 6 Section 3. All amounts paid by the State Treasurer in
- 7 accordance with this act shall be charged against the
- 8 appropriations made for the salaries and wages of the officers
- 9 and employees and other ordinary and general expenses of the
- 10 State government in the General Appropriation Act and other
- 11 appropriation acts of 1976 and 1977.
- 12 Section 4. The funds appropriated in section 1 shall be used
- 13 solely for providing for the programs in existence during the
- 14 fiscal year 1976-1977, which programs shall be funded at no more

- 15 than 25% ONE-TWELFTH of the total appropriations contained in
- 16 Senate Bill No.770, Printer's No.823, Session of 1977.
- 17 Section 5. In addition to the amount appropriated by this
- 18 act, all moneys received from any other source, except from the
- 19 Federal Government, as contributions to or payments for the
- 20 programs provided herein shall be paid into the General Fund to
- 21 the appropriation for the purposes and programs intended.
- 22 Section 6. This act shall take effect immediately.
