AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, further providing for the pension for
- 3 deceased soldier's dependents.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3502 of Title 51, act of November 25,
- 7 1970 (P.L.707, No.230), known as the Pennsylvania Consolidated
- 8 Statutes, is amended and a section is added to read:
- 9 § 3502. Deceased soldier's dependents' pension.
- 10 (a) Amount and persons entitled. -- A pension may be paid to
- 11 either the widow or widower or minor children or dependent
- 12 parent of any member of the Pennsylvania National Guard, who may
- 13 die from injuries received, or who may be killed while in active
- 14 service, under orders of the Governor, which active service
- 15 shall include participation in armory assemblies or
- 16 participation in aerial flights incidental to training. Such
- 17 pension shall be computed on the following basis and distributed

- 1 to the following persons monthly:
- 2 (1) To each minor child, if there is no widow or widower
- entitled to compensation, [\$50] \$75, with [\$25] \$50 for each
- 4 child in excess of two, with a maximum of [\$150] \$200 to be
- 5 paid to their guardian.
- 6 (2) To the widow or widower, if there are no children,
- 7 [\$50] \$100
- 8 (3) To the widow or widower, if there is one child,
- 9 [\$75] \$150.
- 10 (4) To the widow or widower, if there are two children,
- 11 [\$100] \$200.
- 12 (5) To the widow or widower, if there are three
- 13 children, [\$125] <u>\$250</u>.
- 14 (6) To the widow or widower, if there are four or more
- 15 children, [\$150] \$300.
- 16 (7) To the father and mother, if there is no widow,
- 17 widower, or children, if dependent to any extent upon the
- member for support at the time of his death, [\$50] \$100.
- 19 (b) Workmen's compensation. -- Such pension shall be in
- 20 addition to any relief in the form of compensation determined
- 21 under the Workmen's Compensation Law of Pennsylvania as
- 22 authorized by section 3501 (relating to relief for disability
- 23 incurred in active State service).
- 24 (c) Claims. -- All claims for pension under this section shall
- 25 be made to the department, which shall establish rules governing
- 26 the filing of such claims. The department shall investigate all
- 27 circumstances connected with the death of the person and make a
- 28 recommendation to the Adjutant General as to the granting of a
- 29 pension. If a pension is granted, it shall be paid quarterly in
- 30 the manner provided by law.

- 1 (d) Term and removal. -- No pension granted under this section
- 2 shall be granted for a longer period than [five] ten years; but
- 3 [may be renewed, for a further period of five years, upon
- 4 satisfactory evidence of the dependency of the pensioner being
- 5 submitted or obtained by the department] in the case of minor
- 6 children of a deceased member, the pension shall be paid until
- 7 the minor child reaches 18 years of age.
- 8 (e) Revocation. -- The department shall have power to revoke
- 9 any pension granted under this section when it shall be shown to
- 10 the satisfaction of the department that the pensioner is no
- 11 longer in a state of dependency.
- 12 (f) Exemption. -- The provisions of this section shall not
- 13 apply to any member of the Pennsylvania National Guard while in
- 14 the service of the United States, in case of war, or under the
- 15 orders of the President of the United States.
- 16 (g) Appropriation. -- The necessary appropriation to pay any
- 17 pensions granted under this section shall, at each regular
- 18 session of the General Assembly, be included in the items
- 19 pertaining to the department, in the act of Assembly providing
- 20 for the ordinary expenses of the Executive, Judicial, and
- 21 Legislative Departments of the Commonwealth.
- 22 § 3503. Tuition credit.
- 23 (a) Children entitled to tuition credit.--The children of
- 24 members of the Pennsylvania National Guard who were killed or
- 25 die as a result of injuries received while in State active duty
- 26 <u>shall be entitled to a 50% tuition credit at all State-owned</u>
- 27 colleges or universities or approved trade schools for a period
- 28 not exceeding eight semesters or four years.
- 29 (b) Department to control program. -- The department shall
- 30 adopt rules and regulations to carry out the provisions of this

- 1 section and shall administer the tuition credit program
- 2 <u>established herein.</u>
- Section 3. This act shall take effect immediately and apply 3
- 4 to the fiscal year July 1, 1977 and each fiscal year thereafter.
