AN ACT

1 Authorizing the DEPARTMENT OF GENERAL SERVICES WITH THE APPROVAL <—
2 OF THE DEPARTMENT OF ENVIRONMENTAL RESOURCES TO GRANT AN
3 EASEMENT TO THE United States Steel Company to build a pile
4 wall and a cell in the Monongahela River in Rankin Township,
5 Allegheny County.

6 The General Assembly of the Commonwealth of Pennsylvania
7 hereby enacts as follows:

8 Section 1. ~~The United States Steel Company is hereby~~ <—
9 ~~authorized~~ THE DEPARTMENT OF GENERAL SERVICES WITH THE APPROVAL <—
10 OF THE DEPARTMENT OF ENVIRONMENTAL RESOURCES AND THE GOVERNOR IS
11 HEREBY AUTHORIZED TO GRANT TO THE UNITED STATES STEEL COMPANY,
12 ITS SUCCESSORS AND ASSIGNS, AN EASEMENT to build and maintain in
13 the Monongahela River in Rankin Township, Allegheny County, a
14 steel sheet circular cell approximately 17 feet in diameter,
15 protruding above the water approximately 20 feet above the
16 highwater mark and placed on piling extending to bed rock. The
17 cell shall be in line with six existing cells located at
18 milepost 9.5 from the mouth of the river at Rankin Borough. The
19 ~~United States Steel Company may~~ EASEMENT SHALL INCLUDE THE RIGHT <—

1 TO BUILD at the same location as the cells, ~~build~~ a sheet pile <—
2 wall as a debris deflector extending from lands of United States
3 Steel Company at approximately an angle of 45 degrees from the
4 shoreline to an existing cell.

5 SECTION 2. THE UNITED STATES STEEL COMPANY SHALL PROVIDE <—
6 METES AND BOUNDS DESCRIPTION OF THE EASEMENT.

7 SECTION 3. THE CONVEYANCE OF THE EASEMENT SHALL BE APPROVED
8 BY THE DEPARTMENT OF JUSTICE AND SHALL BE EXECUTED BY THE
9 SECRETARY OF GENERAL SERVICES IN THE NAME OF THE COMMONWEALTH.

10 Section ~~2~~ 4. This act shall take effect immediately. <—
