AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, further providing for the surrender of licenses,
- 3 registration plates and cards.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1376 of Title 75, act of November 25,
- 7 1970 (P.L.707, No.230), known as the Pennsylvania Consolidated
- 8 Statutes, is amended to read:
- 9 § 1376. Surrender of registration plates and cards upon
- 10 suspension.
- 11 (a) General rule. -- The department, upon suspending any
- 12 registration, shall require the registration plate or plates and
- 13 registration card to be surrendered immediately to the
- 14 department and may delegate authority to any authorized
- 15 department employee, issuing authority, [or] police officer,
- 16 <u>district constable or writ server</u> to seize the registration

- 1 plate or plates and registration card or cards.
- 2 (b) Issuing authorities, district constables and writ
- 3 servers. -- Whenever the surrender of registration plates and
- 4 cards is accomplished through the use of issuing authorities,
- 5 <u>district constables or writ servers, the procedures for such</u>
- 6 <u>surrender shall be prescribed by general rule by the Supreme</u>
- 7 Court. For each card and plate set recovered by a district
- 8 constable or writ server, such officer shall be paid a fee of
- 9 \$6. In addition, constables shall receive mileage at the rate <--

- 10 <u>otherwise provided by law. \$9 WHICH SHALL INCLUDE MILEAGE.</u>
- 11 (c) Reimbursement of department. -- As a condition for the
- 12 return of a surrendered registration plate and card SURRENDERED <-
- 13 TO A CONSTABLE OR A WRIT SERVER, a person shall reimburse the
- 14 <u>department for the constable's or writ server's fee.</u> A SERVICE <-
- 15 <u>FEE OF \$25.</u>
- [(b)] (d) Penalty.--Any person failing or refusing to
- 17 surrender to the department or to its authorized employee,
- 18 <u>issuing authority</u>, police officer, district constable or writ
- 19 server, upon demand, any registration plate or card which has
- 20 been suspended is guilty of a summary offense and shall, upon
- 21 conviction, be sentenced to pay a fine of \$100.
- 22 Section 2. Title 75 is amended by adding a section to read:
- 23 § 1552. Surrender of license.
- 24 (a) General rule. -- If a license, required by this subchapter
- 25 to be surrendered upon notice of the suspension or revocation of
- 26 operating privileges, is not received by the department within a
- 27 reasonable time, the department may delegate authority to any
- 28 <u>authorized department employee, issuing authority, police</u>
- 29 <u>officer</u>, <u>district constable</u>, <u>or writ server to seize the</u>
- 30 <u>license.</u>

- 1 (b) Issuing authorities, district constables and writ
- 2 <u>servers.--Whenever the surrender of a license is accomplished</u>
- 3 through the use of issuing authorities, district constables or
- 4 writ servers, the procedures for such surrender shall be
- 5 prescribed by general rule by the Supreme Court. For each
- 6 <u>license recovered by a district constable or writ server, such</u>
- 7 <u>officer shall be paid a fee of \$6. In addition, constables shall</u> <---

- 10 (c) Reimbursement of department. -- As a condition for the
- 11 return of a surrendered license SURRENDERED TO A CONSTABLE OR
- 12 WRIT SERVER, a person shall reimburse the department for the
- 13 <u>constable's or unit service's fee.</u> A SERVICE FEE OF \$25.
- 14 (d) Penalty.--Any person failing or refusing to surrender to
- 15 the department or to its authorized employee, issuing authority,
- 16 police officer, district constable or writ server, upon demand,
- 17 any license which has been suspended is quilty of a summary
- 18 offense and shall, upon conviction, be sentenced to pay a fine
- 19 of \$100.
- 20 Section 3. This act shall take effect January 1, 1980.
