AN ACT

- Amending the act of April 9, 1929 (P.L.177, No.175), entitled 2 "An act providing for and reorganizing the conduct of the 3 executive and administrative work of the Commonwealth by the Executive Department thereof and the administrative 4 5 departments, boards, commissions, and officers thereof, including the boards of trustees of State Normal Schools, or 7 Teachers Colleges; abolishing, creating, reorganizing or 8 authorizing the reorganization of certain administrative 9 departments, boards, and commissions; defining the powers and 10 duties of the Governor and other executive and administrative officers, and of the several administrative departments, 11 12 boards, commissions, and officers; fixing the salaries of the 13 Governor, Lieutenant Governor, and certain other executive and administrative officers; providing for the appointment of 14 15 certain administrative officers, and of all deputies and 16 other assistants and employes in certain departments, boards, 17 and commissions; and prescribing the manner in which the number and compensation of the deputies and all other 18 19 assistants and employes of certain departments, boards and 20 commissions shall be determined," further providing for 21 powers of waterways patrolmen and making editorial changes.
- 22 The General Assembly of the Commonwealth of Pennsylvania
- 23 hereby enacts as follows:
- 24 Section 1. Section 2706, act of April 9, 1929, (P.L.177,
- 25 No.175), known as "The Administrative Code of 1929," amended

- 1 April 25, 1949 (P.L.729, No.180), is amended to read:
- 2 Section 2706. Powers of [Fish Wardens] Waterways
- 3 Patrolmen. -- Every member of the Pennsylvania Fish Commission,
- 4 and every [fish warden, and every special fish warden] waterways
- 5 patrolman shall have power:
- 6 (a) To enforce all the laws of the Commonwealth relating to
- 7 fish;
- 8 (b) To execute all warrants and search warrants for the
- 9 violation of the fish laws;
- 10 (c) To serve subpoenas issued for the examination,
- 11 investigation, and trial of all offenses against the laws
- 12 relating to fish;
- 13 (d) To carry firearms, or other weapons, in the performance
- 14 of his duties[, and to stop or halt, by pointing or discharging
- 15 firearms, any person violating or believed to be violating any
- 16 of the laws of the Commonwealth the enforcement of which is
- 17 charged to such officers], and any such officer shall at all
- 18 times be privileged to protect himself in the performance of his
- 19 duty;
- (e) [To search, without warrant, any boat, conveyance,
- 21 vehicle, fish-box, bag, coat, basket, or other receptacle for
- 22 fish, when he has reason to believe that any provision of any
- 23 law of this Commonwealth relating to fish has been violated;] To
- 24 search, where probable cause exists that a violation of this act
- 25 <u>has occurred, any boat, conveyance, vehicle, fish-box, baq,</u>
- 26 coat, boot, basket or other receptacle for fish, when he is
- 27 enforcing the laws of the Commonwealth pertaining to fish:
- 28 Provided, however, That such waterways patrolman shall display
- 29 <u>his badge or other insignia of identification and shall state to</u>
- 30 the person in charge of said vehicle or conveyance the purpose

- 1 of the search;
- 2 (f) To seize and take possession of any and all fish which
- 3 may have been caught, taken, or killed at any time, in any
- 4 manner, or for any purpose, or had in possession, or under
- 5 control, or which have been shipped or are about to be shipped,
- 6 contrary to the laws of this Commonwealth. Fish so seized shall
- 7 be disposed of in any manner as the Executive Director of the
- 8 Commission may direct;
- 9 (g) To enter upon any land or water in the performance of
- 10 his duty;
- 11 (h) To demand and secure proper assistance in case of
- 12 emergency;
- 13 (i) To purchase fish for the purpose of securing evidence.
- 14 Section 2. This act shall take effect immediately.
