AN ACT

1 Amending the act of July 4, 1979 (No.9A), entitled "An act to
2 provide for the expenses of the Executive, Legislative and
3 Judicial Departments of the Commonwealth, the public debt and
4 for the public schools for the fiscal period July 1, 1979 to
5 June 30, 1980, and for the payment of bills incurred and
6 remaining unpaid at the close of the fiscal period ending
7 June 30, 1979," adding language in appropriations to the
8 Departments of Health and Justice.

9 The General Assembly of the Commonwealth of Pennsylvania
10 hereby enacts as follows:

11 Section 1. Section 2, act of July 4, 1979 (No.9A), known as
12 the "General Appropriations Act of 1979," is amended by adding
13 language in the appropriations to the Departments of Health and
14 Justice to read:

15 Section 2. The following sums, or as much thereof as may be
16 necessary, are hereby specifically appropriated from the General
17 Fund to the several hereinafter named agencies of the Executive,
18 Legislative and Judicial Departments of the Commonwealth for the
19 payment of salaries, wages or other compensation and travel
20 expense of the duly elected or appointed officers and employees

1 of the Commonwealth, for payment of fees of contractual services
2 rendered, for the purchase or rental of goods, services,
3 printing, equipment, land and buildings and for payment of any
4 other expenses, as provided by law or by this act, necessary for
5 the proper conduct of the duties, functions and activities and
6 for the purposes hereinafter set forth for the fiscal period
7 beginning July 1, 1979 and for the payment of bills incurred and
8 remaining unpaid at the close of the fiscal period ending June
9 30, 1979.

16 information, medical facilities review, health ser-

19 treatment and life maintenance: Provided,
20 however, That no moneys shall be spent for the
21 purpose of seeking judicial review in any court
22 of the decision of the Honorable David W. Craig
23 of the Commonwealth Court in the case of
24 Canonsburg General Hospital v. Commonwealth of
25 Pennsylvania, Department of Health et. al.
26 (No.2335 C.D.1979)..... \$9,920,000

29 For the salaries, wages and all necessary

2 That no moneys shall be spent for the purpose
