3	limited to cases where the offense is designated a felony or a
4	misdemeanor, or in cases causing or contributing to an accident
5	resulting in injury or death to any person.

7	upon members of the police force of cities of the first class.
8	(q) To have all the powers and prerogatives conferred by law
9	upon constables of the Commonwealth.
10	(r) To serve subpoenas issued for any examination,
