## REFERRED TO APPROPRIATIONS, SEPTEMBER 22, 1980

## AN ACT

Making an appropriation to the Trustees of the University of 1 2 Pittsburgh for the general maintenance and operation of the 3 Western Psychiatric Institute and Clinic. 4 The General Assembly of the Commonwealth of Pennsylvania 5 hereby enacts as follows: 6 Section 1. The sum of \$5,200,000, or as much thereof as may 7 be necessary, is hereby specifically appropriated to the 8 Trustees of the University of Pittsburgh for the fiscal period 9 July 1, 1980 to June 30, 1981, for the general maintenance and operation of the Western Psychiatric Institute and Clinic by the 10 11 University of Pittsburgh and the purchase of such apparatus and 12 equipment as the trustees may deem necessary for the best 13 interest of the purposes of the institute and clinic, which purposes shall include the teaching of personnel for the staffs 14 of the various mental institutions of the Commonwealth and the 15 16 conduct or research in the treatment, prevention and cause of 17 the various types of nervous disorders and mental diseases in compliance with the laws, providing for the lease of the Western 18

Psychiatric Institute and Clinic to the University of 1 Pittsburgh. In addition to the above amount all income and all 2 3 moneys collected at the institute and paid into the General Fund 4 of the State Treasury under existing laws are hereby appropriated out of the General Fund to the institute for the 5 same purposes, the institute to receive from such appropriation 6 the exact amount which was collected at said institute during 7 the said fiscal period. 8

9 Section 2. Payments to the institute on account of the 10 appropriation in section 1 shall be made by the Secretary of 11 Public Welfare.

12 Section 3. All sums of money paid to the Trustees of the 13 University of Pittsburgh pursuant to the appropriation of the 14 act of July 11, 1980 (No.77A), entitled "An act making an 15 appropriation to the Trustees of the University of Pittsburgh 16 for the general maintenance and operation of the Western 17 Psychiatric Institute and Clinic," shall be credited toward and 18 deducted from the amount appropriated in this act.

Section 4. The act of July 11, 1980 (No.77A), entitled "An act making an appropriation to the Trustees of the University of Pittsburgh for the general maintenance and operation of the Western Psychiatric Institute and Clinic," is repealed. Section 5. This act shall take effect immediately.
