AN ACT

- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, providing for
- 3 interpreters for certain deaf persons in civil proceedings.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Title 42, act of November 25, 1970 (P.L.707,
- 7 No.230), known as the Pennsylvania Consolidated Statutes, is
- 8 amended by adding a section to read:
- 9 § 7103. Interpreters for the deaf.
- 10 (a) Civil proceedings. -- In any civil proceeding in which a

- 1 party is deaf the court may appoint an interpreter to assist
- 2 <u>said party throughout the trial proceedings. Disposition</u>

- 3 IMPOSITION of costs shall be in discretion of the court AND MAY
- 4 BE IMPOSED UPON THE COUNTY.
- 5 (b) Oath.--The interpreter shall swear or affirm that he
- 6 will make a true interpretation to the deaf person and that he
- 7 will repeat IN THE SPOKEN ENGLISH LANGUAGE the statements of the
- 8 <u>deaf person to the best of his ability.</u>
- 9 (c) Definitions.--As used in this section the following
- 10 words shall have the meanings given to them in this subsection:
- 11 "Deaf." Persons who are deaf or whose hearing is so impaired
- 12 that they are unable to understand or communicate the spoken
- 13 English language.
- 14 "Interpreter." A person qualified and trained to translate
- 15 for or communicate with deaf persons. Any person certified by
- 16 the National or Local Registry of Interpreters for the Deaf or
- 17 similar registry shall be considered qualified for the purposes
- 18 of this section.
- 19 Section 2. This act shall take effect immediately.
