## AN ACT

- Amending the act of June 18, 1974 (P.L.359, No.120), entitled 2 "An act creating the Municipal Police Officers' Education and 3 Training Commission; providing for the commission's membership, selection, compensation, and removal; providing 5 for the powers and duties of the commission; providing for the appointment and duties of the chairman; providing for the 6 7 act's applicability to the civil service laws; requiring 8 training by certain political subdivisions and police departments; providing penalties for violation thereof; and 9 making an appropriation, "increasing the commission 10 11 membership and quorum requirements.
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. The introductory paragraph and clause (6) of
- 15 subsection (a) of section 4 and section 7, act of June 18, 1974
- 16 (P.L.359, No.120), referred to as the Municipal Police Education
- 17 and Training Law, are amended to read:
- 18 Section 4. Commission Members; Selection, Compensation and
- 19 Removal.--(a) The commission shall be composed of [seventeen]

- 1 <u>eighteen</u> members as follows:

- 3 (6) [Three] <u>FOUR</u> elected officials of the various political <-
- 4 subdivisions of the Commonwealth, to be appointed by the
- 5 Governor; one to be a borough official, one a <u>first class</u>
- 6 township official, one a second class township official, and one
- 7 a city official.
- 8 \* \* \*
- 9 Section 7. Meetings; Quorum. -- The chairman shall summon the
- 10 members of the commission to the first meeting within one
- 11 hundred twenty days of enactment. The commission shall meet at
- 12 least four times each year. Special meetings may be called by
- 13 the chairman of the commission, or upon written request of five
- 14 members. A quorum shall consist of [nine] ten members of the
- 15 commission.
- 16 Section 2. This act shall take effect immediately.
