## AN ACT

Amending the act of October 10, 1974 (P.L.705, No.235), entitled 2 "An act providing for the training and licensing of watch guards, protective patrolmen, detectives and criminal 3 4 investigators, carrying and using lethal weapons in their 5 employment; imposing powers and duties on the Commissioner of the Pennsylvania State Police; and providing penalties," 6 defining "full-time police officer" and providing for certain 8 exemptions from testing and fees. 9 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 10 11 Section 1. Section 3, act of October 10, 1974 (P.L.705, 12 No.235), known as the "Lethal Weapons Training Act," is amended 13 by adding a definition to read: 14 Section 3. Definitions. -- As used in this act: 15 16 "Full-time police officer" means any employee of a city, borough, town, township or county police department assigned to 17 law enforcement duties who works a minimum of forty hours per 18

week per year. The term does not include persons employed to

- 1 check parking meters or to perform only administrative duties,
- 2 nor does it include auxiliary and fire police.

- 4 Section 2. Paragraph (2) of section 5 and subsection (c) of
- 5 section 6 of the act are amended to read:
- 6 Section 5. Power and Duties of Commissioner.--The
- 7 commissioner shall have the power and duty:
- 8 \* \* \*
- 9 (2) To implement and administer or approve physical and
- 10 psychological testing and screening of the candidate for the
- 11 purpose of barring from the program those not physically or
- 12 mentally fit to handle lethal weapons. However, candidates who
- 13 are full-time police officers and have undergone physical and
- 14 psychological examination as a prerequisite to employment or to
- 15 continued employment by their local police departments or who
- 16 were employed as full-time police officers prior to October 10,
- 17 1974 shall not be required to undergo any physical or
- 18 psychological testing and screening procedures so implemented.

- 20 Section 6. Certificate of Qualification. -- \* \* \*
- 21 (c) The application shall be personally presented by the
- 22 applicant at an office of the Pennsylvania State Police where
- 23 his fingerprints shall be affixed thereto. The application shall
- 24 be accompanied by two current photographs of the applicant of a
- 25 size and nature to be prescribed by the commissioner and a
- 26 thirty-five dollar (\$35) application fee, unless the applicant
- 27 is a full-time police officer, in which case no application fee
- 28 <u>shall be required</u>. Thereafter the application shall be forwarded
- 29 to the commissioner.

1 Section 3. This act shall take effect in 60 days.
