18	Section 1. Section 402, act of June 3, 1937 (P.L.1333,	<

22	officers shall be qualified registered electors of the district	
23	in which they are elected or appointed. No person shall be	

- 1 qualified to serve as an election officer who shall hold, or
- 2 shall within two months have held, any office, appointment or
- 3 employment in or under the Government of the United States or of
- 4 this State or of any city[, county, borough, township,
- 5 incorporated town, school district, or county or poor district,
- 6 of any municipal board, commission or trust in any city, save
- 7 only [justices of the peace and aldermen,] district justices,
- 8 notaries public and persons in the militia service of the State;
- 9 nor shall any election officer be eligible to any civil office
- 10 to be voted for at a primary or election at which he shall
- 11 serve, except that of an election officer.
- 12 Section 2. This act shall take effect immediately.
