- 1 BE PAID ON WARRANTS OF THE STATE TREASURER DIRECTLY TO AND IN
- 2 FAVOR OF THE PERSON NAMED IN SAID REQUISITIONS.
- 3 (B) THE SUM OF \$25,000, OR AS MUCH THEREOF AS MAY BE
- 4 NECESSARY, IS HEREBY SPECIFICALLY APPROPRIATED TO THE LOCAL
- 5 GOVERNMENT COMMISSION FOR THE FISCAL PERIOD JULY 1, 1982 TO JUNE
- 6 30, 1983 FOR THE COMPILATION AND DISTRIBUTION OF VARIOUS
- 7 MUNICIPAL CODES.
- 8 SECTION 2. THE SUMS APPROPRIATED IN SECTION 1 ARE IN
- 9 ADDITION TO ANY SUMS APPROPRIATED PURSUANT TO SECTION 201, ACT
- 10 OF MAY 11, 1982 (NO.2A), KNOWN AS THE "GENERAL APPROPRIATION ACT
- 11 OF 1982."
- 12 SECTION 3. THIS ACT SHALL TAKE EFFECT IMMEDIATELY.
