AN ACT

1 Amending Title 42 (Judiciary and Judicial Procedure) of the
2 Pennsylvania Consolidated Statutes, providing for dividing
3 the forty-third judicial district into two separate judicial
4 districts.

5 The General Assembly of the Commonwealth of Pennsylvania
6 hereby enacts as follows:

7 Section 1. Sections 901 and 911 of Title 42, act of November
8 25, 1970 (P.L.707, No.230), known as the Pennsylvania
9 Consolidated Statutes, are amended to read:

10 § 901. Judicial districts.

11 (a) General rule.--The Commonwealth is divided into [59] 60
12 judicial districts, numbered and composed as follows:

26 (b) Change in number or boundaries.--Except as otherwise
27 provided therein, any statute amending subsection (a) so as to
28 change the number or boundaries of the judicial districts of
29 this Commonwealth shall take effect 30 days after the entry of
30 an order of the Supreme Court evidencing the advice and consent

1 of the court to the amendment pursuant to section 11 of Article
2 V of the Constitution of Pennsylvania.

3 § 911. Courts of common pleas.

4 (a) General rule.--There shall be one court of common pleas
5 for each judicial district of this Commonwealth consisting of
6 the following number of judges:

9 (b) Single county districts.--In single county judicial
10 districts the court of common pleas of the district shall be
11 known as the "Court of Common Pleas of (the respective) County."

12 (c) Multicounty districts.--In multicounty judicial
13 districts the court of common pleas of the district shall be
14 known as the "Court of Common Pleas of the (respective) Judicial
15 District." There shall be a separate branch of the court in each
16 county comprising the judicial district.

17 Section 2. This act shall take effect 30 days after the
18 advice and consent of the Supreme Court of Pennsylvania is given
19 by order of the court pursuant to section 11 of Article V of the
20 Constitution of Pennsylvania.
