AN ACT

- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, prohibiting the issuance of firearm
- 3 licenses or registrations to minors.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Sections 6106(c) and 6109(a) of Title 18, act of
- 7 November 25, 1970 (P.L.707, No.230), known as the Pennsylvania
- 8 Consolidated Statutes, are amended to read:
- 9 § 6106. Firearms not to be carried without a license.
- 10 * * *
- 11 (c) Registration required in connection with field or stream
- 12 exemptions. -- Before any exemption shall be granted under
- 13 [paragraphs (b)(9) or (b)(10) of this section] subsection (b)(9)
- 14 or (10) to any person 18 years of age or older licensed to hunt
- 15 or fish or who desires to train dogs, such person shall at the
- 16 time of securing his hunting or fishing license or any time
- 17 after any such license has issued, register with the county
- 18 treasurer the make of the firearm he desires to carry, and the

- 1 caliber and number thereof, on a blank to be furnished by the
- 2 Pennsylvania State Police. The original registration shall be
- 3 delivered to the person registering such firearm, and a copy
- 4 thereof shall be forwarded by the county treasurer to the
- 5 Commissioner of the Pennsylvania State Police. As of January 1,
- 6 1972, the county treasurer shall be entitled to collect a fee of
- 7 50 cents for each such registration of a firearm which fee shall
- 8 be paid to the county. The registration of a firearm, as
- 9 provided in this subsection, shall be good only for the year for
- 10 which the hunting or fishing license in connection with which it
- 11 is granted, is issued.

- 13 § 6109. Licenses.
- 14 (a) Issue of license. -- The chief or head of any police force
- 15 or police department of a city, and, elsewhere, the sheriff of a
- 16 county, may, upon the application of any person 18 years of age
- 17 or older, issue a license to such person to carry a firearm in a
- 18 vehicle or concealed on or about his person within this
- 19 Commonwealth for not more than one year from date of issue, if
- 20 it appears that the applicant has good reason to fear an injury
- 21 to his person or property, or has any other proper reason for
- 22 carrying a firearm, and that he is a suitable person to be so
- 23 licensed.

- 25 Section 2. This act shall take effect in 60 days.
