A SUPPLEMENT

- To the act of July 7, 1972 (P.L.743, No.176), entitled "An act 2 providing for the establishment and operation of Lincoln 3 University as an instrumentality of the Commonwealth to serve as a State-related institution in the higher education system of the Commonwealth; providing for change of name; providing for the composition of the board of trustees; terms of 7 trustees, and the power and duties of such trustees; 8 providing for preference to Pennsylvania residents in 9 tuition; authorizing appropriations in amounts to be fixed annually by the General Assembly; providing for the auditing 10 of accounts of expenditures from said appropriations; 11 providing for public support and capital improvements; 12 13 authorizing the issuance of bonds exempt from taxation within 14 the Commonwealth; requiring the President to make an annual report of the operations of Lincoln University, " making 15 appropriations for carrying the same into effect, providing 16 17 for a basis for payments of such appropriation, and providing 18 a method of accounting for the funds appropriated.
- 19 The General Assembly of the Commonwealth of Pennsylvania
- 20 hereby enacts as follows:
- 21 Section 1. The following sums, or as much thereof as may be
- 22 necessary, is hereby specifically appropriated to the Trustees
- 23 of the College of Lincoln University, Chester County, for the
- 24 fiscal period July 1, 1981 to June 30, 1982, for the purposes
- 25 and in the amounts as shown:

- 1 (1) For educational and general expenses...... \$3,800,000
- 2 (2) For cost of student aid..... 150,000
- 3 (3) For the master's program in human services..... 175,000
- 4 Section 2. Payments to Lincoln University on account of the
- 5 appropriations for the items provided in section 1 shall be made
- 6 on the basis of costs during the fiscal period.
- 7 Section 3. (a) Payments to Lincoln University of the
- 8 appropriation herein provided shall be made monthly during the
- 9 fiscal period.
- 10 (b) Such monthly payments shall be made in accordance with
- 11 the provisions of section 2, on the basis of estimated costs.
- 12 The estimate of costs shall be submitted by Lincoln University
- 13 to the Secretary of Education, the General Assembly and to the
- 14 State Treasurer not later than 30 days prior to the date on
- 15 which such payment is to be made.
- 16 Section 4. Lincoln University shall apply the moneys
- 17 appropriated by this act only for such purposes as are permitted
- 18 in this act and shall at all times maintain proper records
- 19 showing the application of such moneys. Not later than 120 days
- 20 after the close of the fiscal period to which this act relates,
- 21 Lincoln University shall file with the Secretary of Education,
- 22 the General Assembly and with the Auditor General of the
- 23 Commonwealth a statement setting forth the amounts and purposes
- 24 of all expenditures made from moneys appropriated by this act
- 25 and costs, as provided in section 2, used as a basis for receipt
- 26 of any appropriation during said fiscal period. Such statement
- 27 of expenditures and costs shall be reviewed by the Auditor
- 28 General of the Commonwealth, and he shall have the right, in
- 29 respect to the moneys appropriated by this act, to audit and
- 30 disallow expenditures made for purposes not permitted by this

- 1 act. The Auditor General shall also make a determination of
- 2 costs and make certification as to their correctness. In respect
- 3 to expenditures made by the university from moneys other than
- 4 those appropriated by this act, the Auditor General shall have
- 5 the right to review only and he shall file annually with the
- 6 General Assembly such information concerning said expenditures
- 7 as the General Assembly or any of its committees may require.
- 8 Section 5. A report shall be submitted to the Governor and
- 9 the Appropriations and Education Committees of the Senate and
- 10 House of Representatives and shall include data for all programs
- 11 except the Doctor of Medicine program. The report, to be
- 12 submitted prior to September 1, 1982, shall cover the 12-month
- 13 period beginning with the summer term 1981 and shall include:
- 14 (1) The following counts and distributions for each term
- 15 during the period:
- 16 (i) The definitions and numbers of faculty members employed
- 17 full-time, of faculty members employed part-time, of full-time
- 18 students enrolled in graduate courses, of full-time students
- 19 enrolled in undergraduate courses, of part-time students
- 20 enrolled in graduate courses and of part-time students enrolled
- 21 in undergraduate courses.
- 22 (ii) Total numbers of undergraduate student credit hours,
- 23 divided into lower division and upper division course levels,
- 24 and of graduate student credit hours divided into three course
- 25 levels--master's, first professional and doctoral.
- 26 (iii) Number of different courses scheduled by level of
- 27 instruction and the number of sections of individual instruction
- 28 at each level of instruction.
- 29 (iv) Number of terms scheduled and the dates thereof.
- 30 (2) For the summer term and the following academic year in

- 1 total and for each two-digit Hegis category of instructional
- 2 programs in higher education as defined by the National Center
- 3 for Education Statistics, United States Department of Education,
- 4 a classification of faculty members or other professional
- 5 employees by title including: professor, associate professor,
- 6 assistant professor, instructor, lecturer, research associate,
- 7 librarian and academic administrator; faculty members or other
- 8 professional employees under each title to be subdivided by type
- 9 of assignment: teaching and nonteaching, and each such set of
- 10 faculty members or other professional employees to be further
- 11 subdivided by type of employment: full-time or part-time and the
- 12 following aggregates for each such subdivided classification:
- 13 (i) The number of faculty and other professional employees
- 14 and their full-time equivalence in instructional and
- 15 noninstructional functions.
- 16 (ii) The sum of credits assigned to undergraduate classroom
- 17 courses and the sum of credits assigned to graduate classroom
- 18 courses taught, divided into lower division, upper division,
- 19 master's, first professional and doctoral course levels.
- 20 (iii) The sum of undergraduate classroom student credit
- 21 hours and the sum of graduate classroom student credit hours
- 22 generated; divided into lower division, upper division, master's
- 23 first professional and doctoral course levels.
- 24 (iv) The sum of undergraduate individual instruction student
- 25 credit hours and the sum of graduate individual instruction
- 26 student credit hours generated; divided into lower division,
- 27 upper division, master's, first professional and doctoral course
- 28 levels.
- 29 (v) Total salary paid for instructional functions and for
- 30 noninstructional functions and the amount of this salary paid

- 1 for each of these functions from college or university funds,
- 2 Federal funds and other funds.
- 3 (3) For each term of the period covered for each faculty
- 4 member employed full-time identified by two-digit Hegis category
- 5 and title, the report shall contain an analysis of the average
- 6 hours per week spent in college or university-related
- 7 activities, stating specifically hours spent in undergraduate
- 8 classroom contact and graduate classroom contact, hours spent in
- 9 preparation, hours spent in research and hours spent in public
- 10 service.
- 11 Section 6. (a) In addition to the above requirements
- 12 relative to this appropriation, the report covering the 12-month
- 13 period beginning with the summer term 1981, shall include for
- 14 all programs of the university:
- 15 (1) Minimum number of credits required for a baccalaureate
- 16 degree and for a master's degree.
- 17 (2) Number of bachelor's degrees, master's degrees, first
- 18 professional degrees, and doctoral degrees awarded in 1979,
- 19 1980, 1981 and estimated 1982.
- 20 (b) The university shall report its revenues and
- 21 expenditures and present its financial statements required under
- 22 the provisions of this act in accordance with "Higher Education
- 23 Finance Manual" (1975).
- 24 Section 7. The university shall provide such information and
- 25 in such form and manner as the Department of Education may
- 26 prescribe.
- 27 Section 8. The university shall report its revenues and
- 28 expenditures and present its financial statements required under
- 29 the provisions of this act in accordance with generally accepted
- 30 accounting principles and procedures for educational

- 1 institutions as set forth in "Higher Education Finance Manual"
- 2 United States Department of Health, Education and Welfare (1975)
- 3 with the exceptions set forth in the "Commonwealth of
- 4 Pennsylvania Budget Instructions for State-Related Universities,
- 5 Phase I, Fiscal Year 1981-1982." Credits granted for non-
- 6 traditional programs such as CLEP, lifelong learning etc.,
- 7 including all related costs and revenues thereof shall be
- 8 excluded from the function of "Instruction" and included under
- 9 "Public Service."
- 10 Section 9. This act shall take effect July 1, 1981.
