AN ACT

1 Amending the act of December 17, 1982 (No.316), entitled "An act  
2 amending the act of March 10, 1949 (P.L.30, No.14), entitled  
3 'An act relating to the public school system, including  
4 certain provisions applicable as well to private and  
5 parochial schools; amending, revising, consolidating and  
6 changing the laws relating thereto,' further providing for  
7 the number and terms of school directors, for the election  
8 and appointment of intermediate unit directors, for school  
9 district and intermediate unit contracts with day treatment  
10 programs and private residential rehabilitative institutions,  
11 for certain payments of costs of tuition and maintenance of  
12 certain exceptional children, for reimbursement for certain  
13 vocational education expenses, and for tuition charges for  
14 the education of certain nonresident children and reenacting  
15 required annual reports by institutions of the State System  
16 of Higher Education," further providing for the application  
17 of certain provisions.

18 The General Assembly of the Commonwealth of Pennsylvania  
19 hereby enacts as follows:

20 Section 1. Section 10 of the act of December 17, 1982  
21 (No.316), entitled "An act amending the act of March 10, 1949  
22 (P.L.30, No.14), entitled 'An act relating to the public school  
23 system, including certain provisions applicable as well to  
24 private and parochial schools; amending, revising, consolidating  
25 and changing the laws relating thereto,' further providing for

1 the number and terms of school directors, for the election and  
2 appointment of intermediate unit directors, for school district  
3 and intermediate unit contracts with day treatment programs and  
4 private residential rehabilitative institutions, for certain  
5 payments of costs of tuition and maintenance of certain  
6 exceptional children, for reimbursement for certain vocational  
7 education expenses, and for tuition charges for the education of  
8 certain nonresident children and reenacting required annual  
9 reports by institutions of the State System of Higher  
10 Education," is amended to read:

11 Section 10. (a) The provisions of this act affecting  
12 [sections] section 914.1-A[, 1310, 1377, 2502 and 2506.1] of the  
13 "Public School Code of 1949" shall be retroactive to July 1,  
14 1982 as they relate to day treatment programs only and shall not  
15 apply to private residential rehabilitative institutions until  
16 June 30, 1983, and thereafter.

17 (b) The provisions of this act affecting sections 1310,  
18 1377, 2502 and 2506.1 of the "Public School Code of 1949," shall  
19 be retroactive to July 1, 1982.

20 Section 2. This act shall take effect immediately.
