3 AMENDING THE ACT OF JUNE 30, 1984 (NO.11A), ENTITLED "AN ACT <—
4 MAKING APPROPRIATIONS FROM A RESTRICTED REVENUE ACCOUNT
5 WITHIN THE GENERAL FUND TO THE DEPARTMENT OF STATE FOR USE BY
6 THE BUREAU OF PROFESSIONAL AND OCCUPATIONAL AFFAIRS,"
7 INCREASING THE APPROPRIATION; AND DELETING PROVISIONS VETOED
8 BY THE GOVERNOR.

9 The General Assembly of the Commonwealth of Pennsylvania
10 hereby enacts as follows:

11 ~~Section 1. The sum of \$2,095,000 is hereby specifically~~ <—
12 ~~appropriated from the restricted revenue account within the~~
13 ~~General Fund to the Office of Consumer Advocate to provide for~~
14 ~~the operation of that office for the fiscal year July 1, 1983 to~~
15 ~~June 30, 1984.~~

16 ~~Section 2. The appropriation made in section 1 of this act~~
17 ~~shall constitute the final estimate for the fiscal year July 1,~~
18 ~~1983 to June 30, 1984, required by section 904 A.1(a) of the act~~
19 ~~of April 9, 1929 (P.L.177, No.175), known as The Administrative~~

1 ~~Code of 1929, and the total assessment for that fiscal year for~~
2 ~~the purposes of section 904 A.1(b) through (i) and shall~~
3 ~~supersede any other estimate pursuant to section 904 A.1(a) for~~
4 ~~that fiscal year.~~

5 ~~Section 3. This act shall take effect immediately.~~

6 SECTION 1. SECTION 1 OF THE ACT OF JUNE 30, 1984 (NO.11A), <—
7 ENTITLED "AN ACT MAKING APPROPRIATIONS FROM A RESTRICTED REVENUE
8 ACCOUNT WITHIN THE GENERAL FUND TO THE DEPARTMENT OF STATE FOR
9 USE BY THE BUREAU OF PROFESSIONAL AND OCCUPATIONAL AFFAIRS,"
10 VETOED IN PART BY THE GOVERNOR ON JUNE 30, 1984, IS AMENDED TO
11 READ:

12 SECTION 1. [(A)] THE SUM OF [\$7,970,000] \$8,995,000, OR AS
13 MUCH THEREOF AS MAY BE NECESSARY, IS HEREBY APPROPRIATED FROM
14 THE PROFESSIONAL LICENSURE AUGMENTATION RESTRICTED REVENUE
15 ACCOUNT WITHIN THE GENERAL FUND TO THE DEPARTMENT OF STATE TO
16 AUGMENT THE GENERAL GOVERNMENT APPROPRIATION FOR THE OPERATION
17 OF THE BUREAU OF PROFESSIONAL AND OCCUPATIONAL AFFAIRS FOR THE
18 FISCAL YEAR JULY 1, 1984 TO JUNE 30, 1985. [NO FUNDS FROM THIS
19 APPROPRIATION SHALL BE USED TO FUND THE OPERATION OF THE STATE
20 REGISTRATION BOARD OF PROFESSIONAL ENGINEERS.

21 (B) THE SUM OF \$525,000, OR AS MUCH THEREOF AS MAY BE
22 NECESSARY, IS HEREBY APPROPRIATED FROM THE PROFESSIONAL
23 LICENSURE AUGMENTATION RESTRICTED REVENUE ACCOUNT WITHIN THE
24 GENERAL FUND TO THE DEPARTMENT OF STATE TO AUGMENT THE GENERAL
25 GOVERNMENT APPROPRIATION FOR THE OPERATION OF THE STATE
26 REGISTRATION BOARD OF PROFESSIONAL ENGINEERS FOR THE FISCAL YEAR
27 JULY 1, 1984 TO JUNE 30, 1985. FUNDS FROM THIS APPROPRIATION
28 MAY BE USED TO FUND TEST SITES, TRAVEL EXPENSES AND CONSULTANT
29 FEES AT THE DISCRETION OF THE STATE REGISTRATION BOARD FOR
30 PROFESSIONAL ENGINEERS.]

1 SECTION 2. THIS ACT SHALL TAKE EFFECT IMMEDIATELY AND SHALL
2 BE RETROACTIVE TO JULY 1, 1984.
