AN ACT

- 1 Amending the act of June 24, 1931 (P.L.1206, No.331), entitled
- 2 "An act concerning townships of the first class; amending,
- 3 revising, consolidating, and changing the law relating
- 4 thereto, " further providing for records.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Section 1503 of the act of June 24, 1931
- 8 (P.L.1206, No.331), known as The First Class Township Code,
- 9 reenacted and amended May 27, 1949 (P.L.1955, No.569) and
- 10 amended July 1, 1968 (P.L.286, No.140), is amended to read:
- 11 Section 1503. Typewritten, Printed, Photostated and
- 12 Microfilmed Records Valid; Recording or Transcribing Records. --
- 13 All township records required to be recorded or transcribed
- 14 shall be deemed valid if typewritten, printed, photostated or
- 15 microfilmed, and where recording in a specified book of record
- 16 is required, [except] including minutes of the proceedings of
- 17 the board of commissioners, such records may be recorded or
- 18 transcribed in a mechanical [or key-operated] post binder book

- 1 CAPABLE OF BEING PERMANENTLY SEALED with consecutively numbered
- 2 pages WITH A SECURITY CODE PRINTED THEREON AND A PERMANENT
- 3 LOCKING DEVICE with the township seal being impressed upon each
- 4 page, or bound book with pages being consecutively numbered by
- 5 transcribing directly upon the pages of such book of record or
- 6 may be attached thereto to such book of record by stapling or by
- 7 glue or any other adhesive substance or material, and all
- 8 records heretofore recorded or transcribed in any manner
- 9 authorized by this section are validated. [The minutes of
- 10 proceedings of the board of commissioners shall, in the manner
- 11 prescribed by this section for other records, be recorded in a
- 12 bound book.] When any record shall be recorded or transcribed
- 13 after the effective date of this amendment by attaching such
- 14 record or a copy thereof to the book of record as hereinabove
- 15 provided, the township seal shall be impressed upon each page to
- 16 which such record is attached, each impression thereof covering
- 17 both a portion of the attached record and a portion of the page
- 18 of the book of record to which such record is attached.
- 19 Section 2. This act shall take effect in 60 days.
